RESOLUTION 20-R-03

A RESOLUTION WAIVING THE FORMAL BIDDING PROCESS AND AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH PACE ANALYTICAL SERVICES, INC TO PROVIDE EPA MANDATED SAMPLING AND TESTING OF SANITARY SEWER DISCHARGE FROM VARIOUS INDUSTRIES AND BACTERIA TESTING OF DRINKING WATER IN THE CITY OF VANDALIA FOR CALENDAR YEARS 2020 AND 2021

The resolution, which bears the foregoing title, was unanimously adopted Monday, February 3, 2020, by the Council of the City of Vandalia. It waives the formal bidding process and authorizes the city manager to enter into a contract with Pace Analytical Services, Inc to provide EPA mandated sampling and testing of sanitary sewer discharge from various industries and bacteria testing of drinking water in the City of Vandalia for calendar years 2020 and 2021.
