RESOLUTION 20-R-30

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH LJB, INC FOR PART ONE OF THE DESIGN AND ENGINEERING OF THE VANDALIA BIKEWAY CONNECTOR WHICH WILL BE THE FEASIBILITY STUDY TO DETERMINE THE BEST ROUTE FOR THE BIKE PATH

The resolution, which bears the foregoing title, was unanimously adopted Monday, May 18, 2020, by the Council of the City of Vandalia. It authorizes the city manager to enter into a contract with LJB, Inc for part one of the design and engineering of the Vandalia Bikeway Connector which will be the feasibility study to determine the best route for the bike path.
