RESOLUTION 19-R-52

A RESOLUTION AUTHORIZING THE CITY MANAGER TO CONTRACT WITH MAXIM ROOFING COMPANY FOR ROOF REPAIRS AT FIRE STATION TWO AT THE PRICE OF \$82,826.00
