RESOLUTION 19-R-50

A RESOLUTION AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO ENTER INTO AN AGREEMENT WITH MIAMI VALLEY LIGHTING, LLC, AND GUILLMEN ESTATES HOME OWNERS ASSOCIATION REGARDING STREET LIGHTING
