RESOLUTION 19-R-56

A RESOLUTION AUTHORIZING THE PURCHASE OF 6 - 18,800 POUND CAPACITY MOBILE COLUMN PORTABLE VEHICLE LIFTS, REQUESTED BY THE PUBLIC WORKS DEPARTMENT, FROM OTT EQUIPMENT SERVICE, INC. IN THE AMOUNT OF \$66,712.96

The resolution, which bears the foregoing title, was unanimously adopted Monday, November 4, 2019, by the Council of the City of Vandalia. It authorizes the purchase of 6 - 18,800 pound capacity mobile column portable vehicle lifts, requested by the Public Works Department, from Ott Equipment Service, Inc. in the amount of \$66,712.96.
