RESOLUTION 19-R-58

A RESOLUTION ESTABLISHING A CRISIS INTERVENTION TRAINING FUND

The resolution, which bears the foregoing title, was unanimously adopted Monday, December 2, 2019, by the Council of the City of Vandalia. It establishes a crisis intervention training fund. ORDINANCE 19-31

AN ORDINANCE REZONING 7.73 ACRES OF PROPERTY COMMONLY KNOWN AS PART OF 3320 BENCHWOOD ROAD FROM RESIDENTIAL SINGLE-FAMILY 1 TO GATEWAY BUSINESS AND AMENDING THE ZONING MAP OF THE CITY

The ordinance, which bears the foregoing title, was unanimously approved in its first reading Monday, December 2, 2019, by the Council of the City of Vandalia. This ordinance rezones 7.73 acres of property commonly known as part of 3320 Benchwood Road from Residential Single-Family 1 to Gateway Business and amends the zoning map of the city. A public hearing will be held on the proposed ordinance and the ordinance will be considered for final adoption by the Council of the City of Vandalia, Ohio on Monday, December 16, 2019 at 7:00 p.m., in Council Chambers, 333 J.E. AN ORDINANCE TO AMEND PART FOURTEEN, BUILDING AND HOUSING CODE, TITLE TWO, BUILDING STANDARDS OF THE CODIFIED ORDINANCES OF THE CITY OF VANDALIA BY PROVIDING CHAPTER 1484 DEALING WITH NUISANCE PROPERTIES

The ordinance, which bears the foregoing title, was unanimously approved in its second reading Monday, December 2, 2019, by the Council of the City of Vandalia. This ordinance amends Part Fourteen, Building and Housing Code, Title Two, Building Standards of the codified ordinances of the city of Vandalia by providing Chapter 1484 dealing with nuisance properties. This ordinance amends Part Six General Code of the codified ordinances of the city of Vandalia by amending Chapter 642 by adding a new Section 642.20 dealing with criminal activity as a nuisance. ORDINANCE 19-24

AN ORDINANCE TO MAKE APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE CITY OF VANDALIA, OHIO DURING THE CALENDAR YEAR ENDING DECEMBER 31, 2020 AND DECLARING AN EMERGENCY

The ordinance, which bears the foregoing title, was unanimously approved in an emergency reading Monday, December 2, 2019, by the Council of the City of Vandalia. This ordinance makes appropriations for current expenses and other expenditures of the city of Vandalia, Ohio during the calendar year ending December 31, 2020 and declares an emergency. ORDINANCE 19-26

AN ORDINANCE APPROVING THE CITY WIDE 2020 PAY SCALE AND PROVIDING A COST OF LIVING ALLOWANCE FOR CERTAIN EMPLOYEES AND DECLARING AN EMERGENCY

The ordinance, which bears the foregoing title, was unanimously approved in an emergency reading Monday, December 2, 2019 by the Council of the City of Vandalia. This ordinance approves a city wide 2020 pay scale and provides a cost of living allowance for certain employees and declares an emergency. AN ORDINANCE TO AMEND CERTAIN PROVISIONS IN THE VANDALIA CODIFIED ORDINANCES RELATING TO FIREARMS IN ORDER TO COMPLY WITH CHANGES IN THE STATE LAW AND DECLARING AN EMERGENCY

The ordinance, which bears the foregoing title, was unanimously approved in an emergency reading Monday, December 2, 2019, by the Council of the City of Vandalia. This ordinance amends certain provisions in the Vandalia codified ordinances relating to firearms in order to comply with changes in the state law and declares an emergency. ORDINANCE 19-30

AN ORDINANCE TO AMEND CERTAIN PROVISIONS IN CHAPTER 884 OF THE CITY'S CODIFIED ORDINANCES BEING THE CITY INCOME TAX CODE TO INCORPORATE CHANGES IN THE TAX LAW REQUIRED BY THE STATE OF OHIO AND DECLARING AN EMERGENCY

The ordinance, which bears the foregoing title, was unanimously approved in an emergency reading Monday, December 2, 2019, by the Council of the City of Vandalia. This ordinance amends certain provisions in chapter 884 of the city's codified ordinances being the city income tax code to incorporate changes in the tax law required by the State of Ohio and declares an emergency.
