RESOLUTION 19-R-07

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT FOR THE DESIGN AND ENGINEERING OF THE NORTHWOODS BOULEVARD WITH CHOICE ONE ENGINEERING IN THE AMOUNT NOT TO EXCEED \$55,000.00

The resolution which bears the foregoing title was unanimously adopted Monday, February 4, 2019, by the Council of the City of Vandalia. It authorizes the City Manager to enter into a contract for the design and engineering of the Northwoods Boulevard with Choice One Engineering in the amount not to exceed \$55,000.00. A RESOLUTION WAIVING THE FORMAL BIDDING PROCESS AND AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH PACE ANALYTICAL SERVICES, INC TO PROVIDE EPA MANDATED SAMPLING AND TESTING OF SANITARY SEWER DISCHARGE FROM VARIOUS INDUSTRIES AND BACTERIA TESTING OF DRINKING WATER IN THE CITY OF VANDALIA FOR CALENDAR YEAR 2019
