RESOLUTION 19-R-15

ORDINANCE 19-03

AN ORDINANCE REZONING PROPERTY LOCATED AT 5377 OLD SPRINGFIELD ROAD FROM RESIDENTIAL SINGLE-FAMILY 1 (RSF-1) TO AGRICULTURE (A) AND AMENDING THE ZONING MAP OF THE CITY

The ordinance, which bears the foregoing title was denied 6-0 in its first reading Monday, March 4, 2019, by the Council of the City of Vandalia. It would rezone property located at 5377 Old Springfield Road from Residential Single-Family 1 (RSF-1) to Agriculture (A) and amend the zoning map of the city. A public hearing will be held on the proposed ordinance and the ordinance will be considered for final adoption by the Council of the City of Vandalia, Ohio on Monday, March 18, 2019 at 7:00 p.m., in Council Chambers, 333 J.E.
