### **RESOLUTION 19-R-18**

A RESOLUTION WAIVING THE FORMAL BIDDING AND AUTHORIZING THE PURCHASE OF A BATTERY BACKUP SYSTEM UPGRADE, REQUESTED BY THE IT DEPARTMENT, FROM SHI IN THE AMOUNT OF \$28,804.64

The resolution which bears the foregoing title was unanimously adopted Monday, March 18, 2019, by the Council of the City of Vandalia. It waives the formal bidding and authorizes the purchase of a battery backup system upgrade, requested by the IT Department, from Shi in the amount of \$28,804.64. It awards the bid for equipment and complete equipment installation for three police vehicles and one command vehicle, requested by the Division of Police, to K.E. A RESOLUTION AUTHORIZING THE CITY MANAGER TO TERMINATE THE EXISTING AGREEMENT FOR THE CULTURAL ARTS PROGRAM ENDOWMENT FUND WITH THE DAYTON FOUNDATION; HAVE ALL PUBLIC MONEY IN SUCH FUND RETURNED TO THE CITY; AUTHORIZING A NEW AGREEMENT WITH THE DAYTON FOUNDATION TO ESTABLISH THE VANDALIA CULTURAL ARTS PROGRAM COMMITTEE ADVISED FIELD OF INTEREST FUND; AUTHORIZING THE DONATION OF NON TAX REVENUES TO THE NEW FUND; AND PROVIDE FOR THE VANDALIA CULTURAL ARTS COMMITTEE TO BE A RECOMMENDING COMMITTEE FOR SUCH NEW FUND

The resolution which bears the foregoing title was unanimously adopted Monday, March 18, 2019, by the Council of the City of Vandalia. It authorizes the city manager to terminate the existing agreement for the Cultural Arts Program Endowment Fund with the Dayton Foundation; have all public money in such fund returned to the City; authorizes a new agreement with the Dayton Foundation to establish the Vandalia Cultural Arts Program Committee advised field of interest fund; authorizes the donation of non tax revenues to the new fund; and provides for the Vandalia Cultural Arts Committee to be a recommending committee for such new fund. ## **ORDINANCE 19-03**

AN ORDINANCE REZONING PROPERTY LOCATED AT 5377 OLD SPRINGFIELD ROAD FROM RESIDENTIAL SINGLE-FAMILY 1 (RSF-1) TO AGRICULTURE (A) AND AMENDING THE ZONING MAP OF THE CITY

The ordinance, which bears the foregoing title was unanimously denied in its second reading Monday, March 18, 2019, by the Council of the City of Vandalia. It would have rezoned property located at 5377 Old Springfield Road from Residential Single-Family 1 (RSF-1) to Agriculture (a) and amending the zoning map of the city. ## **ORDINANCE 19-04**
