RESOLUTION 19-R-27

A RESOLUTION AWARDING THE BID FOR THE RESURFACING OF VARIOUS STREETS, REQUESTED BY THE PUBLIC WORKS DEPARTMENT, TO JOHN R. JURGENSON, CO. AT THE LOWEST AND BEST BID PRICE OF \$218,973.15

A RESOLUTION AUTHORIZING THE PURCHASE OF A BOBCAT T650 SKID LOADER IN THE AMOUNT OF THE STATE BID PRICE AND PURCHASE AN ADDITIONAL ATTACHMENT FOR THE SKID LOADER FROM BOBCAT COMPANY OF WEST FARGO, NORTH DAKOTA DBA CLARK EQUIPMENT COMPANY AND DECLARING THE EXISTING 1996 MODEL AS SURPLUS PROPERTY

AN ORDINANCE AMENDING THE VANDALIA ZONING CODE TABLE 1224-2: PERMITTED ACCESSORY USES AND STRUCTURES, AND CITY CODE SECTION 1224.01(E) "STANDARDS FOR SPECIFIC ACCESSORY USES AND STRUCTURES", TO PERMIT THE RAISING OF CHICKENS
