RESOLUTION 19-R-27

A RESOLUTION AWARDING THE BID FOR THE RESURFACING OF VARIOUS STREETS, REQUESTED BY THE PUBLIC WORKS DEPARTMENT, TO JOHN R. JURGENSON, CO. AT THE LOWEST AND BEST BID PRICE OF \$218,973.15

The resolution which bears the foregoing title was unanimously adopted Monday, May 6, 2019, by the Council of the City of Vandalia. It awards the bid for the resurfacing of various streets, requested by the Public Works Department, to John R. Jurgenson, Co. at the lowest and best bid price of \$218,973.15. AN ORDINANCE AMENDING THE VANDALIA ZONING CODE TABLE 1224-2: PERMITTED ACCESSORY USES AND STRUCTURES, AND CITY CODE SECTION 1224.01(E) "STANDARDS FOR SPECIFIC ACCESSORY USES AND STRUCTURES", TO PERMIT THE RAISING OF CHICKENS
