### RESOLUTION 19-R-30

**A RESOLUTION APPROVING AND AUTHORIZING THE PLANNING AND RESURFACING NATIONAL ROAD/BROWN SCHOOL ROAD/NATIONAL ROAD (U.S. 40) BETWEEN DAYTON INTERNATIONAL AIRPORT ACCESS ROAD AND THE GREAT MIAMI RIVER, EXCLUDING BRIDGES AND SOME APPROACH SLABS, INCLUDING PAVEMENT MARKINGS, LYING WITHIN THE CITY OF VANDALIA**

The resolution which bears the foregoing title was unanimously adopted Monday, May 20, 2019, by the Council of the City of Vandalia. It approves and authorizes the planning and resurfacing National Road/Brown School Road/National Road (U.S. 40) between Dayton International Airport Access Road and the Great Miami River, excluding bridges and some approach slabs, including pavement markings, lying within the City of Vandalia. It authorizes a temporary advance and subsequent reimbursement between various funds of the city for expenses relating to the ODOT US 40 Resurfacing Project and declaring an emergency.
