#### **RESOLUTION NO. 18-R-04**

A RESOLUTION AUTHORIZING THE PURCHASE OF FIFTEEN SETS OF JANESVILLE (LION APPAREL) FIRE PROTECTIVE CLOTHING, REQUESTED BY THE DIVISION OF FIRE, FROM PHOENIX SAFETY OUTFITTERS AT THE STATE OF OHIO CONTRACT BID PRICE OF \$29,400

The resolution, which bears the foregoing title, was unanimously adopted on Tuesday, January 16, 2018 by the Council of the City of Vandalia. It authorizes the purchase of fifteen sets of Janesville (Lion Apparel) fire protective clothing, requested by the Division of Fire, from Phoenix Safety Outfitters at the State of Ohio contract bid price of \$29,400.
