RESOLUTION 18-R-36

A RESOLUTION DECLARING VARIOUS ITEMS AS SURPLUS AND AUTHORIZING DISPOSAL OF SUCH ITEMS

The resolution which bears the foregoing title was unanimously adopted Monday, May 7, 2018, by the Council of the City of Vandalia. ORDINANCE 18-10

AN ORDINANCE REZONING PROPERTY LOCATED AT 3325 STOP EIGHT ROAD AND 6196 POE AVENUE FROM OFFICE/INDUSTRIAL PARK AND INDUSTRIAL PUD TO HIGHWAY BUSINESS “HB” AND AMENDING THE ZONING MAP OF THE CITY

The ordinance, which bears the foregoing title was unanimously adopted in its first reading Monday, May 7, 2018, by the Council of the City of Vandalia. It rezones property located at 3325 Stop Eight Road and 6196 Poe Avenue from office/industrial park and industrial PUD to highway business “HB” and amending the zoning map of the city. The proposed ordinance will be considered for final adoption by the Council of the City of Vandalia, Ohio on Monday, May 21, 2018 at 7:00 p.m., in Council Chambers, 333 J.E. AN ORDINANCE TO REVISE APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE CITY OF VANDALIA, MONTGOMERY COUNTY, OHIO DURING THE CALENDAR YEAR ENDING DECEMBER 31, 2018, AND AMENDING ORDINANCE 17-30 AND DECLARING AN EMERGENCY

The ordinance, which bears the foregoing title was unanimously adopted in an emergency reading Monday, May 7, 2018, by the Council of the City of Vandalia. It revises appropriations for current expenses and other expenditures of the city of Vandalia, Montgomery County, Ohio during the calendar year ending December 31, 2018, and amending ordinance 17-30 and declaring an emergency. ORDINANCE 18-09

AN ORDINANCE ENACTING NEW CHAPTER 1031 ENTITLED AREAS DESIGNATED FOR UNDER GROUND UTILITIES TO TITLE TWO, STREETS AND SIDEWALKS, OF PART TEN, STREETS, UTILITIES AND PUBLIC WAYS OF THE CODIFIED ORDINANCES OF THE CITY OF VANDALIA AND DECLARING AN EMERGENCY

The ordinance, which bears the foregoing title was unanimously adopted in an emergency reading Monday, May 7, 2018, by the Council of the City of Vandalia. It enacts new Chapter 1031 entitled Areas Designated for Under Ground Utilities to Title Two, Streets And Sidewalks, of Part Ten, Streets, Utilities and Public Ways of the codified ordinances of the city of Vandalia and declaring an emergency. ORDINANCE NO. 18-07

AN ORDINANCE APPROVING THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AND RESOLUTIONS AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES; PROVIDING FOR THE ADOPTION AND PUBLICATION OF NEW MATTER IN THE UPDATED AND REVISED CODIFIED ORDINANCES; AND REPEALING ORDINANCES AND RESOLUTIONS IN CONFLICT THEREWITH

It approves the editing and inclusion of certain ordinances and resolutions as parts of the various component codes of the codified ordinances; providing for the adoption and publication of new matter in the updated and revised codified ordinances; and repealing ordinances and resolutions in conflict therewith.
