RESOLUTION 17-R-34

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A LPA FEDERAL ODOT-LET PROJECT AGREEMENT AND CONTRACTS WITH OHIO DEPARTMENT OF TRANSPORTATION REGARDING THE MILL AND RESURFACING AND CERTAIN BRIDGE DECK REPAIRS ON AIRPORT ACCESS ROAD AS A SINGLE PROJECT BEING PID NO. 103062
