RESOLUTION 16-R-76

A RESOLUTION WAIVING FORMAL BIDDING AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH INTERACTIVE HEALTH FOR VOLUNTARY HEALTH EVALUATIONS FOR VANDALIA FULL TIME EMPLOYEES, COUNCIL MEMBERS, ELIGIBLE PART TIME AND CONTRACTUAL EMPLOYEES AND ELIGIBLE SPOUSES, AND TO OFFER GIFT CARD INCENTIVES TO ENCOURAGE PARTICIPATION

The resolution, which bears the foregoing title, was unanimously adopted on Monday, September 19, 2016 by the Council of the City of Vandalia. It waives formal bidding and authorizes the city manager to enter into an agreement with Interactive Health for voluntary health evaluations for Vandalia full time employees, council members, eligible part time and contractual employees and eligible spouses, and to offer gift card incentives to encourage participation. A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A FIRST AMENDMENT TO THE JOINT FACILITY USE AGREEMENT BETWEEN THE CITY AND VANDALIA-BUTLER BOARD OF EDUCATION WITH RESPECT TO CERTAIN TENNIS COURTS

It authorizes the city manager to enter into a first amendment to the joint facility use agreement between the city and Vandalia-Butler Board of Education with respect to certain tennis courts.
