#### **RESOLUTION 16-R-81**

# A RESOLUTION WAIVING THE FORMAL BIDDING PROCESS AND AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO ENTER INTO AN AGREEMENT WITH ASPHALT SEALCOATERS OF DAYTON FOR THE HELKE PARK TENNIS COURT REPAIRS & RESURFACING PROJECT IN THE QUOTED PRICE OF \$68,244
