RESOLUTION 16-R-68

A RESOLUTION APPROVING THE RECORD PLAN FOR STONEQUARRY CROSSINGS SECTION THIRTEEN

ORDINANCE NO. 16-28

AN ORDINANCE IMPOSING A TEMPORARY MORATORIUM ON THE ACCEPTANCE, CONSIDERATION AND/OR GRANTING OF ANY APPLICATIONS FOR LOCAL LICENSING APPROVAL, AND/OR ANY ZONING, OCCUPANCY, OR OTHER PERMITS RELATING TO CULTIVATORS, PROCESSORS OR RETAIL DISPENSARIES OF MEDICAL MARIJUANA WITHIN THE CITY OF VANDALIA AND DECLARING AN EMERGENCY

The ordinance which bears the foregoing title was unanimously adopted as an emergency measure Monday, August 15, 2016, by the Council of the City of Vandalia for the immediate preservation of the peace, health, safety, and welfare of the citizens of the City of Vandalia and imposes a temporary moratorium on the acceptance, consideration and/or granting of any applications for local licensing approval, and/or any zoning, occupancy, or other permits relating to cultivators, processors or retail dispensaries of medical marijuana within the city of Vandalia and declaring an emergency.
