RESOLUTION 16-R-60

A RESOLUTION DESIGNATING CERTAIN FINANCIAL INSTITUTIONS AS DEPOSITORIES FOR ACTIVE, INTERIM AND INACTIVE FUNDS OF THE CITY OF VANDALIA FOR THE FIVE (5) YEAR PERIOD COMMENCING AUGUST 23, 2016, AUTHORIZING DEPOSITORY AGREEMENTS WITH SAID INSTITUTIONS

The resolution, which bears the foregoing title, was unanimously adopted on Monday, July 18, 2016 by the Council of the City of Vandalia. It designates certain financial institutions as depositories for active, interim and inactive funds of the City of Vandalia for the five (5) year period commencing August 23, 2016, authorizing depository agreements with said institutions. CD16T) WITH THE PROCEEDS OF TAX EXEMPT DEBT OF THE STATE OF OHIO

AN ORDINANCE TO ADOPT AND IMPLEMENT THE PROCEDURES UNDER CHAPTER 5722 OF THE OHIO REVISED CODE TO FACILITATE REUTILIZATION OF NONPRODUCTIVE LAND SITUATED WITHIN THE CITY OF VANDALIA, OHIO AND ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE MONTGOMERY COUNTY LAND REUTILIZATION CORPORATION REGARDING SUCH LAND.
