RESOLUTION 16-R-100

A RESOLUTION AWARDING THE BID FOR THE INSTALLATION OF A NEW HVAC SYSTEM FOR CASSEL HILLS GOLF COURSE CLUBHOUSE, REQUESTED BY THE PARKS AND RECREATION DEPARTMENT, TO MECHANICAL SYSTEMS OF DAYTON IN THE AMOUNT OF \$17,387

This ordinance amends sections 1232.04, 1234.03, 1273.02, 1273.06(A), and 1273.07 and repealing section 1273.10 of the planning and zoning code within the codified ordinances of the city of Vandalia regarding variance criteria and planned unit development amendments.
