AN ORDINANCE PROVIDING FOR THE ISSUANCE AND SALE OF NOTES IN THE MAXIMUM PRINCIPAL AMOUNT OF \$1,399,000, IN ANTICIPATION OF THE ISSUANCE OF BONDS, TO PROVIDE MONEYS FOR THE RETIREMENT OF THE CITY'S OUTSTANDING TAXABLE LAND ACQUISITION NOTES, SERIES 2019, AND DECLARING AN EMERGENCY

The ordinance, which bears the foregoing title, was unanimously approved in an emergency reading Monday, June 21, 2021, by the Council of the City of Vandalia. The ordinance provides for the issuance and sale of notes in the maximum principal amount of \$1,399,000, in anticipation of the issuance of bonds, to provide moneys for the retirement of the City's outstanding taxable land acquisition notes, series 2019, and declaring an emergency.
