

Council Action

In an effort to increase awareness and understanding, this publication was created to detail and explain the actions of the Vandalia City Council. We hope this promotes a better understanding of the role Council plays in keeping Vandalia a great place to live, work and play.

Council took the following actions at the Monday, July 19 meeting:

- ✔ Established the date for the next regular City Council meeting on August 23, 2021, rather than August 16 as originally scheduled.
- ✔ Authorized a one-year extension of time to construct a sidewalk fronting lots 42-45 in Brown School Village Section 4.
- ✔ Approved Resolution 21-R-41 authorizing the City Manager to enter into a contract with Rumpke of Ohio for Municipal Waste services. This contract is for a two-year period with an annual increase of 4%.
- ✔ Approved Resolution 21-R-42 authorizing the City Manager to execute an agreement with the Ohio Department of Transportation for snow and ice removal within the City's corporate limits on Airport Access Road. This agreement will allow both parties greater continuity in respective routes and result in a cost savings to the City.
- ✔ Approved Resolution 21-R-43 awarding the bid for police cruiser equipment purchase and installation to K.E. Rose Company at a bid price of \$46,536. The 2021 budgeted amount for this project is \$49,350. The remaining funds will be used for the installation of decals and graphics by a separate vendor.
- ✔ Approved Resolution 21-R-44 authorizing the City Manager to apply to Montgomery County for Community Development Block Grant Funds to a new play structure in Helke Park.
- ✔ Approved Resolution 21-R-45 authorizing the City Manager to enter into a contract with LJB for engineering & design services for the Vandalia Bikeway Connector in the amount of \$309,698. The City was awarded funding through MVRPC in the amount of \$2,136,703 for the construction of the connector. Design and engineering costs are to be shared by the City and Five Rivers Metro Parks.
- ✔ Moved to a second reading Ordinance 21-18 a request for a PUD Major Amendment to allow the expansion of a detached garage for property located at 139 S. Dixie Drive.
- ✔ Moved to a second reading Ordinance 21-19 a request to rezone 2700 W. National Road from Highway Business to Industrial.
- ✔ Moved to a second reading Ordinance 21-20 which would amend Section 642.16 of the Vandalia Codified Ordinances in order to efficiently enforce nuisance activities within the City.
- ✔ Adopted, as an emergency, Ordinance 21-17 authorizing the assessment of properties for delinquent accounts related to storm water fees, trash collection, sewer and water.
