RESOLUTION 21-R-60

A RESOLUTION TO ENTER INTO A COST SHARING AGREEMENT WITH MONTGOMERY COUNTY FOR ENGINEERING AND DESIGN OF IMPROVEMENTS FOR A NORTHERN RING ROAD AROUND THE DAYTON INTERNATIONAL AIRPORT

The resolution, which bears the foregoing title, was unanimously approved Monday, September 20, 2021, by the Council of the City of Vandalia. The resolution authorizes the City Manager, or his designee, to enter into a cost sharing agreement with Montgomery County for engineering and design of improvements for a northern ring road around the Dayton International Airport. AN ORDINANCE REZONING 6.8581 ACRES OF LAND LOCATED AT 3325 STOP EIGHT ROAD FROM HIGHWAY BUSINESS (HB) TO INDUSTRIAL (I) AND AMENDING THE ZONING MAP OF THE CITY

It rezones 6.8581 acres of land located at 3325 Stop Eight Road from Highway Business (HB) to Industrial (I) and amending the zoning map of the City.
