It extends the limited temporary moratorium on the acceptance, consideration and/or granting of any applications for zoning regarding properties west of Airport Access Road and declaring an emergency. #### **ORDINANCE 21-33**

AN ORDINANCE AMENDING VARIOUS SECTIONS OF THE VANDALIA ZONING CODE TO INCLUDE THE "INDUSTRIAL/INNOVATION" ZONING DISTRICT INCLUDING ITS PURPOSE, PROPOSED LOCATION, USES, DEVELOPMENT STANDARDS, AND APPLICABILITY TO OTHER EXISTING REGULATIONS

The ordinance, which bears the foregoing title, was unanimously approved in the first reading reading Monday, December 6, 2021, by the Council of the City of Vandalia. It amends various sections of the Vandalia Zoning Code to include the "industrial/innovation" zoning district including its purpose, proposed location, uses, development standards, and applicability to other existing regulations. A public hearing will be held on the proposed ordinance and the ordinance will be considered for final adoption by the Council of the City of Vandalia, Ohio on Monday, December 20, 2021 at 7:00 p.m., in Council Chambers, 333 J.E. #### **ORDINANCE 21-34**

AN ORDINANCE REZONING 470 ACRES OF LAND GENERALLY LOCATED WEST OF AIRPORT ACCESS ROAD TO THE WESTERN CITY LIMITS FROM AGRICULTURE, HIGHWAY BUSINESS, AND OFFICE/INDUSTRIAL PARK TO INDUSTRIAL/INNOVATION AND AMENDING THE ZONING MAP OF THE CITY

The ordinance, which bears the foregoing title, was unanimously approved in the first reading Monday, December 6, 2021, by the Council of the City of Vandalia. It rezones 470 acres of land generally located west of Airport Access Road to the western city limits from agriculture, highway business, and office/industrial park to industrial/innovation and amending the zoning map of the city. A public hearing will be held on the proposed ordinance and the ordinance will be considered for final adoption by the Council of the City of Vandalia, Ohio on Monday, December 20, 2021 at 7:00 p.m., in Council Chambers, 333 J.E.
