RESOLUTION 22-R-03

A RESOLUTION AUTHORIZING THE PURCHASE OF TEN SETS OF LION APPAREL FIRE PROTECTIVE CLOTHING, REQUESTED BY THE DIVISION OF FIRE, FROM PHOENIX SAFETY OUTFITTERS AT A PRICE OF \$33,774

The resolution, which bears the foregoing title, was unanimously approved Tuesday, January 18, 2022, by the Council of the City of Vandalia. The resolution authorizes the purchase of ten sets of Lion Apparel Fire Protective Clothing, requested by the Division of Fire, from Phoenix Safety Outfitters at a price of \$33,774.
