## AN ORDINANCE REZONING .996 ACRES OF LAND LOCATED AT 3324 BENCHWOOD ROAD FROM GATEWAY BUSINESS (GB) TO HIGHWAY BUSINESS (HB) AND AMENDING THE ZONING MAP OF THE CITY
