AN ORDINANCE APPROVING A PLANNED UNIT DEVELOPMENT PRELIMINARY DEVELOPMENT PLAN AND ASSOCIATED ZONING MAP CHANGE FOR COPPERFIELD TOWNS ON LAND GENERALLY LOCATED AT 3330 MULBERRY ROAD
