RESOLUTION 22-R-50

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT TO PROVIDE ELECTRIC SERVICE TO THE DOG LEG ROAD SANITARY SEWER LIFT STATION WITH AES OHIO IN THE AMOUNT OF \$71,380.11

It authorizes the City Manager to enter into an agreement to provide electric service to the dog leg road sanitary sewer lift station with AES Ohio in the amount of \$71,380.11. ORDINANCE NO. 22-30

AN ORDINANCE AN ORDINANCE AMENDING VANDALIA CODE SECTION 678.02 CARRYING CONCEALED WEAPONS AND 678.04 IMPROPERLY HANDLING OF A FIREARM IN A MOTOR VEHICLE IN ORDER TO BE COMPLIANT WITH NEW STATE LAW AND DECLARING AN EMERGENCY

The ordinance, which bears the foregoing title, was unanimously approved in an emergency reading Monday, July 18, 2022, by the Council of the City of Vandalia. It amends Vandalia code section 678.02 carrying concealed weapons and 678.04 improperly handling of a firearm in a motor vehicle in order to be compliant with new state law and declaring an emergency.
