RESOLUTION 22-R-48

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT FOR THE WEBSTER STREET RESURFACING ENGINEERING WITH IBI GROUP IN THE AMOUNT OF \$22,820.00
