ORDINANCE 22-36

ORDINANCE AUTHORIZING A TEMPORARY ADVANCE AND REIMBURSEMENT BETWEEN THE GENERAL FUND AND THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) OF THE CITY FOR EXPENSES RELATING TO THE CDBG PLAYGROUND EQUIPMENT PROJECT, TOGETHER WITH ALL RELATED ITEMS, AND DECLARING AN EMERGENCY

The ordinance, which bears the foregoing title, was unanimously approved Monday, September 19, 2022, by the Council of the City of Vandalia. It authorizes a temporary advance and reimbursement between the General Fund and the Community Development Block Grant (CDBG) of the City for expenses relating to the CDBG playground equipment project, together with all related items, and declaring an emergency. ORDINANCE 22-35

AN ORDINANCE AMENDING VANDALIA CODIFIED ORDINANCES SECTIONS 1042.11, 1044.06(d), AND 1045.28 REGARDING WATER, SEWER, WASTE WATER TREATMENT AND STORM WATER DRAINAGE RATES

The ordinance, which bears the foregoing title, was tabled 5-0, until October 3, 2022 by the Council of the City of Vandalia on Monday, September 19, 2022. It would have amended the Vandalia Codified Ordinances sections 1042.11, 1044.06(d) and 1045.28 regarding water, sewer, waste water treatment and storm water drainage rates. A public hearing will be held on the proposed ordinance and the ordinance will be considered for final adoption by the City Council of Vandalia, Ohio on Monday, October 3, 2022 at 7:00 p.m., in Council Chambers, 333 J.E.
