ORDINANCE 22-35

AN ORDINANCE AMENDING VANDALIA CODIFIED ORDINANCES SECTIONS 1042.11, 1044.06(d), AND 1045.28 REGARDING WATER, SEWER, WASTE WATER TREATMENT AND STORM WATER DRAINAGE RATES

The ordinance, which bears the foregoing title, was unanimously approved in the first reading Monday, October 3, 2022, by the Council of the City of Vandalia. It amends the Vandalia Codified Ordinances sections 1042.11, 1044.06(d) and 1045.28 regarding water, sewer, waste water treatment and storm water drainage rates. A public hearing will be held on the proposed ordinance and the ordinance will be considered for final adoption by the City Council of Vandalia, Ohio on Monday, October 17, 2022 at 7:00 p.m., in Council Chambers, 333 J.E.
