RESOLUTION 22-R-74

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH QUALITY LANDSCAPE, LAWN & FENCE INC. OF CASSTOWN, OHIO FOR THE SPORTS COMPLEX BALLFIELD FENCE REPLACEMENT PROJECT IN AN AMOUNT OF \$38,670
