ORDINANCE 22-44

AN ORDINANCE REZONING APPROXIMATELY 13.4 ACRES OF LAND LOCATED AT 7249 NORTH DIXIE DRIVE FROM HIGHWAY BUSINESS (HB) TO INDUSTRIAL (I) AND AMENDING THE ZONING MAP OF THE CITY

The ordinance, which bears the foregoing title, was approved 6-0, with one abstention, in the first reading Monday, December 5, 2022, by the Council of the City of Vandalia. It rezones approximately 13.4 acres of land located at 7249 North Dixie Drive from Highway Business (HB) to Industrial (I) and amending the zoning map of the City. A public hearing will be held on the proposed ordinance and the ordinance will be considered for final adoption by the City Council of Vandalia, Ohio on Monday, December 19, 2022 at 7:00 p.m., in Council Chambers, 333 J.E.
