## **RESOLUTION 20-R-62**

### A RESOLUTION DECLARING VARIOUS ITEMS AS SURPLUS AND AUTHORIZING DISPOSAL OF SUCH ITEMS

The resolution, which bears the foregoing title, was unanimously adopted Monday, October 19, 2020, by the Council of the City of Vandalia.
