RESOLUTION 20-R-71

A RESOLUTION STRONGLY OPPOSING SENATE BILL 352 AND HOUSE BILL 754, LEGISLATION PROPOSING THE REPEAL OF SECTION 29 OF 197, WHICH WILL RESULT IN A MYRIAD OF UNINTENDED CONSEQUENCES THROUGH OHIO'S ENTIRE MUNICIPAL INCOME TAX SYSTEM, CAUSE A SUBSTANTIAL LOSS OF REVENUE THAT WILL IMPEDE THE ABILITY OF MUNICIPALITIES TO PROVIDE FOR THE HEALTH, SAFETY AND WELFARE OF MUNICIPAL RESIDENTS AND BUSINESSES AND THEREBY JEOPARDIZE THE FUTURE ECONOMIC GROWTH OF THE STATE OF OHIO

The resolution, which bears the foregoing title, was unanimously tabled Monday, December 7, 2020, by the Council of the City of Vandalia. It strongly opposes Senate Bill 352 and House Bill 754, legislation proposing the repeal of Section 29 of 197, which will result in a myriad of unintended consequences through Ohio's entire municipal income tax system, cause a substantial loss of revenue that will impede the ability of municipalities to provide for the health, safety and welfare of municipal residents and businesses and thereby jeopardize the future economic growth of the State of Ohio.
