S. Cassel Rd. Bridge Replacement: Persistence pays off! This week, Director Cron was informed by the Ohio Department of Transportation that the City is being

awarded a Municipal Bridge Program grant of up to \$1,313,211 in federal funds for the replacement of the city-owned S. Cassel Rd. bridge (Johnson Station) that services Unibilt Industries. The City has applied for and been denied this funding in the past, and self-funding this needed replacement would have been an incredible burden on the City's resources as the bridge services just one business. Congrats to Director Cron and the team at LJB Engineering on this huge win for the City of Vandalia.











Study Session:

Monday, October 16, 2023 Items:

Resolution: Surface Transportation Funds - Miami Valley Regional Planning Commission is accepting applications for consideration for Surface Transportation Program (STP) funding. This year they will accept applications for resurfacing projects to be funded in the Fiscal Years 2028 and 2029. Applications for simple resurfacing are only available every few years. Engineering would begin in 2026. The City is proposing to apply for the resurfacing of Poe Avenue from Stop Eight Road to Image Drive, Wyse Road from I-75 to Webster Street and Miller Lane from Stop Eight Road to Benchwood Drive. As part of the application, we are required to submit a Resolution supporting the project and guaranteeing our local share of the funding.

Resolution: Settlement Agreement with Prairie Flyer Energy Storage, LLC - This resolution authorizes the City Manager to enter into a settlement agreement with Prairie Flyer Storage, LLC, a wholly owned subsidiary of Jupiter Power, LLC. Prairie Flyer intends to purchase a 19.3-acre parcel located in the City of Vandalia in order to construct and operate a battery energy storage system. It has applied to the Ohio Power Sitting Board for a Certificate of Environmental Compatibility and Public Need with respect to the Project. The City raised concerns about the Project and Certificate in a letter to OPSB in March and was considering formally intervening in the OPSB matter. However, after meeting with Prairie Flyer on multiple occasions the parties have reached a Settlement Agreement.

Ordinance: Assessment of Nuisance Abatements – The City obtained nuisance abatement orders from the court for two parcels, 6325 Shady Knoll Drive and 841 Spartan Avenue. The structures on the parcels were then razed by the City pursuant to the court order. As the costs to raze the nuisance structures have not been paid, this ordinance is necessary for the city to assess the cost to the property owners and have the County Auditor place the amounts due upon the tax list and duplicate.

Ordinance: Assessments September - This emergency ordinance assesses properties for delinquent accounts related to storm water fees, trash collection, delinquent sewer & water, weed cutting and property maintenance.

Monday, November 6. 2023 Items:

Resolution: TCA – AES Easement Request - Tri Cities Wastewater Authority currently owns the property around the City of Vandalia's old wastewater treatment plant which is near the CSX Railroad. AES Ohio (formally known as DP&L) have power poles and overhead electric transmission lines in this area. Some of the poles and lines need to be replaced. Records do not show a recorded easement in the area where work needs to take place. AES Ohio is requesting an easement from Tri Cities to install, to maintain and to repair the poles and lines. Being that Tri Cities is an entity made up of Vandalia, Tipp City and Huber Heights, the easement must be signed by all three cities. I am requesting the approval of a resolution authorizing the City Manager to sign attached easement on behalf of the City of Vandalia so that AES Ohio can complete the replacement of poles and transmission lines.

Resolution: PC 23-10 – Record Plan - LBD Enterprises Plat -3505 Mulberry - Jacob Agullana, on behalf of LBD Enterprises, LLC, has submitted an application requesting subdivision approval for the LBD Enterprises Plat. The property is located between Langford Drive and Mulberry Road in the City of Vandalia. The proposed record plan would divide the existing parcel into two new parcels totaling 2.891 acres +/-, with the additional dedication of 0.273 acres of public right-of-way. The subject properties are located in the Residential Single Family (RSF-2) zoning district. On October 10, 2023, the Planning Commission voted 3-0 to recommend approval.

Discussion Items:

Variance BZA 23-11: Total Accessory Structure Area – 1340 South Dixie Drive - The Applicant, William Jackson has requested a variance to allow the construction of a detached garage that would cause the total area of all accessory structures to exceed 40% of the principal building footprint (326 square foot maximum) for the property located at 1340 South Dixie Drive. The applicant has proposed adding a 1,200 square foot detached garage to the side yard of his property. There is an existing 64 square foot shed. On October 11, 2023, the Board of Zoning Appeals voted 3-0 to recommend approval.

Variance BZA 23-12: Total Accessory Structure Area – 570 O'Hara Court – The Applicant, Cole Ward has requested a variance to allow the construction of a detached garage that would cause the total area of all accessory structures to exceed 600 square feet for the property located at 570 O'Hara Court. The applicant has proposed adding a 676 square foot detached garage to the rear of his property. There is an existing 192 square foot shed. On October 11, 2023, the Board of Zoning Appeals voted 3-0 to recommend approval.

Introduction and Oath of Office: Fire Fighter/Paramedic/Inspector Ricky Davis II - City Manager Wendt will introduce and administer the Oath of Office to Fire Fighter/Paramedic/Inspector Ricky Davis II who began full time employment October 11, 2023.

Resolutions

Resolution 23-R-65: 2024 Council Summer Schedule- This resolution proposes that during the months of June, July and August, City Council would meet once per month, on the 3rd Monday of each month. Study sessions will be scheduled to begin at 5:30 pm with the regular business meetings starting at 7:00 pm. The official dates for 2024 would be June 17, July 15, and August 19.

Resolution 23-R-66: Sanitary Sewer Slip Lining Bids- Bids were opened publicly for the Sanitary Sewer Slip Lining project on Tuesday September 26, 2023. Attached is a copy of the bid tabulation sheet for referenced bids. Five sets of specifications were issued, and three contractors submitted bids for the project. Bids ranged from \$97,982.00 to \$125,454.00. Our estimate for the project was \$100,000. We have been awarded \$50,000 in Community Development Block Grant Funding for this project and we have funds appropriated in the Sanitary Sewer portion of the 2023 Capital Improvement budget for this project. Director Cron recommends awarding the contract for this project to Insight Pipe Contracting as the lowest and best bid at their bid price of \$97,982.

Resolution 23-R-67: Accepting the Amounts and Rates as Determined by the Budget Commission and Authorizing the Necessary Tax Levies and Certifying them to the County Auditor – This resolution will accept the Amounts and Rates for Tax Year 2022. The Montgomery County Auditor noted the Amounts and Rates are subject to change due to election results and value changes.

Resolution 23-R-68: Surface Transportation Funds - Miami Valley Regional Planning Commission is accepting applications for consideration for Surface Transportation Program (STP) funding. This year they will accept applications for resurfacing projects to be funded in the Fiscal Years 2028 and 2029. Applications for simple resurfacing are only available every few years. Engineering would begin in 2026. Ordinance – First Reading:

Ordinance 23-26: City-Initiated Rezoning to PF and OIP – This City-initiated rezoning involves nineteen parcels totaling 126.812 acres +/-, located in the following locations: 810 Northwoods Blvd., 815 Foley Dr., Webster Street approximately 500 feet south of Park Center Blvd., the intersection of Old Springfield and Old Canal Roads, and the southeast end of Johnson Station Rd. As proposed, the subject properties would be rezoned from Agriculture (A), Residential Single-Family 3 (RSF-3), Gateway Business (GB), Highway Business (HB), Office/Industrial Park (O/IP), and Industrial (I) to the Public Facilities (PF) and Office Industrial Park (O/IP) Zoning Districts. On September 26, the Planning Commission voted 5-0 to recommend approval of the proposed rezoning.

Ordinance 23-27: Assessment of Nuisance Abatements – The City obtained nuisance abatement orders from the court for two parcels, 6325 Shady Knoll Drive and 841 Spartan Avenue. The structures on the parcels were then razed by the City pursuant to the court order. As the costs to raze the nuisance structures have not been paid, this ordinance is necessary for the city to assess the cost to the property owners and have the County Auditor place the amounts due upon the tax list and duplicate.

Ordinance 23-28: 2024 Budget - This ordinance authorizes appropriations for FY 2024. The City's operating, capital, and revitalization budget is a policy document and fiscal plan that we use to set out anticipated revenue and expenditures for accomplishing a variety of public services over a given time. Our budget is an expression of our priorities and the resources that we are strategically dedicating toward improving quality of life for our residents, corporate citizens, and anyone who visits Vandalia. The fourth 2024 operating, maintenance, capital, and revitalization budget workshop was held at the Justice Center in the Community Room at 2:00 p.m. on Thursday, October 12, 2023. Thank you to our senior staff members who provided additional background information involving many of the tough considerations that were before the City Council. There is no doubting this team's commitment to providing top-tier public services, while developing a strong fiscal plan that will help us work towards our Citywide Policy Goals. This budget aligns with the policy direction that has been established by the Vandalia City Council. Since 2021, City Council has celebrated our team's success in capturing approximately \$15,438,656 million in committed and anticipated grants, donations, and external funding to stretch taxpayer funds.

I have no doubt that this is the City's most comprehensive forecast to date. Thank you to the City Council for the many inquiries, and efforts of due diligence – this has improved the way we do business and should bolster the public's trust and confidence in the Council's management of their resources. This year, Finance Director Leiter, Assistant Finance Director Carnes, ACM Holloway, and I have worked with our team to assemble a more comprehensive capital improvement plan, to study and to predict probable revenue streams, and to include potential future debt service payments for transformative projects. We have used these analyses to demonstrate feasibility and financial sustainability, and to account for possible future staffing proposals that will make Vandalia an increasingly safe and secure community. Thank you to Director Leiter who has spent nights and weekends preparing and modifying the many iterations of this budget. I am proud of the LJB facilities maintenance master plan that Director Clark, Superintendent Wells, and Inspector Mastrino produced as we wrap up the ~\$9 million roof and HVAC infrastructure project. This

third-party document will help our team to communicate needs more effectively and to plan out how we care for the public's investment in our buildings, grounds, parking lots, and other facilities. Also, during this process, we brought in the City's financial advisor and bond counsel to work with the City Council and our administrative team to help us gain a richer understanding of the subtleties relating to public sector fund accounting, bond ratings, the practices of rating agencies, general obligation debt versus revenue debt, as well as to provide an evaluation and analysis of the many opportunities and options that are before the City Council.

This year, the budget process began on July 1, 2023, when the Finance Department prepared electronic workbooks for the departments. Our team worked on departmental budgets and returned them to the Finance Department for initial review in early August. Assistant City Manager Amber Holloway, Director Leiter, Assistant Director Carnes, and I met with each department to study budget requests and service delivery needs, which we juxtaposed with budgetary constraints and competing priorities. On September 11, 2023, I met with the City Council to discuss the 2024 budget at the fall retreat. Our team also met for budget workshops on September 14, 18, 27; the October 2 study session; and a fourth budget workshop on October 12, 2023. These exercises in due diligence are worthy and necessary because they help us grow as a cohesive team, build understanding, and demonstrate transparency to our community.

This is truly an exciting budget and five-year forecast. I commend the staff and the City Council for their critical thought and desire to improve the way we do business by addressing deferred items, working towards industry standards, and implementing modern technologies to make us more efficient. This budget is nearly identical to the budget that we produce after budget workshop #3, which was presented at the October 2, 2023, study session. The budget includes the following highlights:

- \$1,573,329 to purchase and to upfit two police cruisers in 2024 and three cruisers in each of the years during 2025 2028;
- \$375,000 to replace a medic unit (ambulance) in 2025 and \$400,000 to replace a medic unit in 2027 understanding that delivery from the time of purchase will take 18 24 months;
- \$3,886,014 to build the Vandalia bikeway connector from Taylorsville Metro Park to Bunkers including \$3,011,359 in grant and external funding in years 2024 and 2025;
- \$60,000 in traffic signal preemption devices that will make our police officers, firefighters, and residents safer during an emergency response;
- \$55,000 for training equipment and props for our Firefighter / Paramedic / Inspectors;
- \$1,000,000 in street resurfacing and \$380,000 in curb, sidewalk, and concrete work with a three percent escalator in each of the next five years;
- \$1,000,000 for resurfacing Wester St. including a grant of \$717,132 that the City has never received before;
- \$1,764,000 including an offset of a \$900,000 grant to replace the watermains and to resurface Tionda Drive, Mossview, and Ranchview;
- \$150,000 in asphalt maintenance for the walking paths at the Sports Complex;
- \$500,000 for new water meters;
- \$650,020 to construct and inclusive playground for children of all abilities in Robinette Park in 2024 with \$113,856 coming from the City's capital improvement funds;
- A placeholder of \$570,000 to build a splash pad, to maintain asphalt, and to make other improvements to Robinette Park in 2025 – with \$275,000 coming from the City's capital improvement funds;
- The addition of one full-time Parks Maintenance Technician in 2024;
- A placeholder for forecasted possible addition of three full-time Firefighter / Paramedic / Inspectors in 2025;
- A placeholder forecasted possible addition of three full-time Firefighter / Paramedic / Inspectors in 2028;
- Placeholders for forecasted annual debt service payments of \$310,000 from utility funds for the Dog Leg Rd. Utility Extension Project – Phase II;
- Placeholders for forecasted annual debt service payments of ~\$1.4 mm from various funds for a new public works facility on Northwoods Boulevard where the city secured a 16-acre donation of land valued at \$900,000;
- Placeholders for forecasted debt annual debt service payments of \$170,000 for the Cassel Hills Golf Course Irrigation Project;

- \$80,000 to conduct a downtown master plan that will be guided by community members and reflect our ongoing market study;
- An active transportation plan to make Vandalia more walkable and bikeable; and
- A five-year strategy for developing and building the National Rd. streetscape and road diet.

The 2024 budget is scheduled to be on the October 16, 2023, Council Meeting agenda for a first reading. This will be the seventh time that the City Council has met to consider the 2024 budget. Pending passage in a first reading, the budget is scheduled for a second reading and adoption on November 6, 2023.

Ordinance - Second Reading:

Ordinance 23-24 Fire Insurance: City Manager Wendt requested that Law Director McDonald draft this ordinance to empower the City of Vandalia to obtain a portion of fire insurance proceeds when there is a major loss. This type of ordinance is commonly used in other communities to help ensure that insurance proceeds are used to abate blight resulting from a structure fire, to protect public safety, and to help prevent the need to appropriate tax dollars to abate such blight. If adopted, the City of Vandalia would be able to hold a portion of fire insurance proceeds in a fund to ensure that proceeds are used to tear down the building (or repair it) – whether by the owner or by the City. It is worth noting that this ordinance will not be enforceable at the Super 8 Motel, which recently had a structure fire. The ordinance will apply to all properties that are damaged by a fire after the ordinance takes effect.

Ordinance – Emergency Reading:

Ordinance 23-25 – Assessments – This emergency ordinance assesses properties for delinquent accounts related to storm water fees, trash collection, delinquent sewer & water, weed cutting and property maintenance.

Anyone wishing to be heard on a topic will need to appear personally at the meeting. **The Study Session will begin at 6:00 pm followed by the City Council Meeting at 7:00 pm.**



Dear Mr. Cron:

The Ohio Department of Transportation (ODOT) is pleased to inform you that the S. Cassel Road Bridge Replacement project (SFN 5765145) has been selected for funding in the Municipal Bridge Program. The project selections are contingent upon the availability of future federal funds.

With the Bridge Formula Program funding through the most recent Federal Transportation Bill, off-system bridges must be funded at 100% for construction and construction engineering. Therefore, the program will provide 100% of the eligible costs, up to a maximum of \$1,313,211 in Federal funds through the Municipal Bridge Program, in State Fiscal Year (SFY) 2027. Please note, if contingencies were included in the requested amount, they were removed prior to awarding funds per the program guidance.

All options should be considered during the Project Development Process, not just a partial width build.

Please provide written acceptance of the awarded Municipal Bridge funds by **Thursday**, **November 30**, **2023** via email to <u>Nichole.Lawhorn@dot.ohio.gov</u>. If acceptance is not received by this date, the funds will be rescinded and awarded to another project in order to ensure a fully funded program.

Please contact Blake Simpson, in the ODOT District 7 office at (937) 497-6807, to schedule a project scope meeting and to start the process of programming your project. It is very important to establish solid commitment dates for your project. Failure to meet the agreed upon dates could result in funding being withdrawn.
