The Blue Letter

January 12, 2024

Honorable Mayor & Esteemed City Councilmembers:

<u>Tuesday</u>, January 16th, 2024, Council Meeting: Study Session will begin at 5:30 pm. The Council meeting will begin at 7:00 pm.

Martin Luther King, Jr. Day: City offices will be closed in observance of Martin Luther King Jr. Day on Monday.

Focus Vandalia (LINK): This week, Human Resources Manager Pruszynski was featured in our Focus Vandalia video on employee recruiting. Our teammates are our biggest asset, every time we hire a new public servant, it is a considerable investment that can impact our organization and community for decades. We put a lot of resources in trying to draw the right combination of attitude, work ethic, and call to service.

Cassel Rd. Bridge (Johnson Station Rd. Bridge) Replacement Update: Last week, I updated Council on the City's

award of a state municipal bridge grant of \$1,382,327. ODOT, in certain years, offer assistance for the preliminary engineering and final design costs in the form of a *design task order*. This money is available on a first come first serve basis. We were fortunate enough to receive the task order funding in an amount not to exceed \$200,000 to replace the Johnson Station Rd bridge. ODOT selects a third-party firm through a Quality Based Selection (QBS) process for the engineering and design of the project and then negotiates a contract price.



ODOT has selected Prime AE as the firm to perform the preliminary engineering and final design for the project. Prime AE's proposal cost for the work is approximately \$260,000, which would leave our share of the engineering at \$60,000. Because the task order is capped at \$200,000, we are required to enter into a separate agreement for our share of the engineering. Prime AE has agreed to separate their initial proposal into two separate proposals (one for ODOT and one for City of Vandalia) to best utilize the \$200,000 from ODOT. Ultimately the City will be responsible for approximately 4% of the entire \$1,641,444 of the project.

The City is still currently waiting on the necessary final agreements and orders from ODOT and Prime AE's revised proposals related to the design of the bridge. It is unlikely that this information will be ready for the meeting on Tuesday. There are some bureaucratic deadlines that the City must meet, and there have been delays in processing the











necessary agreements, which are out of the City's control. To receive the grant funds, I will request that City Council waive formal bidding, and authorize me to negotiate and to enter into the agreement with Prime AE as design professional since they will also be entering into an agreement with ODOT for the larger portion of the work (Note: It would not make sense for the City and the State to contract two different design professionals for the same small bridge project – and ODOT has already conducted a QBS selection process and award.)

After providing this update at the Tuesday, January 16, 2024, Council Meeting; I will then request that Council consider and authorize the necessary legislation in the Study Session and Regular Meetings on February 5, 2024. Failure to meet this deadline could result in the City paying for the entire \$1,641,444 project out of pocket.

There are several projects with funds appropriated in our current capital improvement budget, and I feel comfortable utilizing the \$60,000 from these various funds and projects because this reallocation will not cause substantial negative impact to any individual project scope (e.g., concrete, paving). Alternatively, the City could consider supplementing the capital budget by \$60,000 later this year if necessary. Regardless, I recommend that the City take the necessary actions to meet the timelines in order to utilize the funding for the bridge replacement project at the February 5, 2024 Study Session and Regular Meeting of City Council.

Bruce Sucher Vandalia Recreation Center Memberships: This week, there were some inquiries related to memberships at the Bruce Sucher Vandalia Recreation Center. Rate and membership information is on the City website at: https://vandaliaohio.org/308/Memberships. This has been published in the MyVandalia Magazine and sent to every residence. Since the recreation center opened in 2001, there have been three updates to membership rates including:

- 2007 5% increase to all categories (including residents);
- 2009 5% increase to business and non-resident categories; and
- 2011 addition of the Dual membership category (which reduced revenue).

Resident members of the VRC have experienced one rate increase of 5% in 23 years – it occurred 17 years ago.

On December 18, 2023, Director Leiter reported that through November 30, 2023, the VRC was running at 57.08% cost recovery compared to 71.43% in 2019. This comparison includes approximately \$111,000 more in capital expenditures in 2019. This does not include the capital expenditures or debt service related to the facilities infrastructure project, which included replacing the original roof and commercial heating, ventilation, and air conditioning for the entire facility. From 2019 to 2023, revenues declined from \$1,044,191 in 2019 to \$854,508 in 2023, while operating expenditures increased from \$1,221,423 to \$1,360,928 during the same period. In this case, the VRC is still recovering from the COVID-19 exodus.

Utilities: The City has received some inquiries regarding utilities in Vandalia. Information regarding the utility system needs and rates can be found online at: www.vandaliaohio.org/utilities. The figures regarding the Tri-Cities plant improvement are estimates from late 2022, meaning that the actual bid amounts are likely to be higher.

Ordinance: Assessments – This emergency ordinance assesses properties for delinquent accounts related to storm water fees, trash collection, delinquent sewer & water, weed cutting and property maintenance

Monday, February 5, 2024, Items:

Resolution: Purchase of Water Meters – Public Works crews have been installing the new ultrasonic meters that we have in stock as our current meters continue to fail at a rapid pace. To date, we have ordered 3,000 of the roughly 5,700 water meters in operation in the City. Our latest order of 1,300 meters in August 2023 is estimated for delivery in February. In the 2024 Capital Improvement Budget, we have appropriated a total of \$500,000 in the Water and Sanitary Sewer funds to purchase more water meters to continue the multi-year citywide replacement.

Buckeye State Pipe & Supply Company, Inc. has agreed to hold their 2023 pricing for us until May 2024. Due to the long lead time and held pricing, Director Borton recommends we purchase more Badger E-Series Ultrasonic Meters from Buckeye State Pipe & Supply Company, Inc. for an amount not to exceed \$500,000. This will cover the cost of approximately 1,300 more residential meters and appurtenances.

Resolution: One Ton Dump Truck #15 Cab & Chassis – In the 2024 Capital Improvement Budget, we have appropriated a total of \$100,000 in various funds to purchase a new one-ton dump truck to replace our current Public Works truck #15, with over 55,700 miles before this snow & ice season. The dump trucks are used throughout the year on a daily basis moving spoils, hauling brush, gravel, asphalt, and general maintenance. Our six main snow & ice vehicles are responsible for clearing over 210 lane miles of roadway during the snow & ice events.

We received the State contract pricing and a quote with government discount pricing from Beau Townsend Ford of Vandalia for a new one-ton dump truck cab & chassis. Under Vandalia Code section 208.03(d)(1), known as the Vandalia First purchasing option, Beau Townsend's price is within the 2% requirement for purchases over \$50,000. I recommend we waive formal bidding and purchase the cab & chassis as specified from Beau Townsend Ford at their quoted price with government incentives of \$60,884.00.

Variance: BZA 24-01 Monument Sign – 113 West National Road-Kettering Health - The Applicant, Select Signs, on behalf of Kettering Health has requested a variance to the "prohibited signs" requirement for the property located at 113 West National Road. The Applicant has proposed adding a monument sign in the Vandalia City Center Overlay (VCCO). On January 10, 2024, the Board of Zoning Appeals voted 5-0 to recommend approval with two conditions.

Discussion Items:

One Ton Dump Truck # 15 Upfit Plow & Salt Spreader - As mentioned above, in the 2024 Capital Improvement Budget, we have appropriated a total of \$100,000 in various funds to purchase a new one-ton dump truck to replace our current Public Works truck #15. During snow & ice events, we currently use 3/4-ton pickup trucks for plowing culde-sacs and narrow streets, but they cannot put down salt afterwards; another truck must be pulled from plowing its route to salt those areas. This new one-ton truck would be upfit with a dump body, 10' plow, and salt spreading capabilities to start mitigating this issue. Our dump trucks are used throughout the year daily moving spoils, hauling brush, gravel, asphalt, and general maintenance.

We received a quote from K. E. Rose Company of Huber Heights for the upfit with snow & ice equipment with government discount pricing. We have used the K. E. Rose Company in the past for most of our snow & ice upfits and they have performed excellent work at a reasonable price. They are just now finishing the upfit of our newest single axle five-yard dump truck that should be out on the streets this month. I recommend we purchase the upfit dump body with snow & ice equipment as specified by K.E. Rose Company with government incentives for \$48,140.00.

The total cost of the cab & chassis and the upfit would be \$109,024.00 which is \$9,024.00 over the amount appropriated of \$100,000. We have \$15,000 available that is not needed for the 2024 appropriated tire changing equipment, which was purchased with 2023 funds in November. This will cover the \$9,024.00 over the amount appropriated for the dump truck.

Resolution 24-R-05: Managed Endpoint Detection and Response (MEDR) Service - IT Manager Davey presented his recommendation for Managed Endpoint Detection and Response (MEDR) services at the January 2, 2024, Council workshop. Proposed resolution 24-R-05 recommends that the city enter into a three-year contract with SilverSky, Inc., at a cost of \$33,300 per year, as well as a one-time setup free of \$1,387.50. The managed endpoint detection and response services will greatly enhance the city's cybersecurity capabilities and fill the gap for afterhours cybersecurity monitoring. Resolution 24-R-05 is on the January 16, 2024, council agenda for approval.
