

#### The Blue Letter

Monday, February 12, 2024 - Focus Vandalia - Fire Awards

Focus Vandalia (LINK): The recent Focus Vandalia showcases the annual Division of Fire meeting and service awards. During the meeting, Chief Follick recognized our veterans and active service members who are serving on the Division.

### Priority Development Advisory Committee (PDAC): The

Dayton Development Coalition and many community partners work together to evaluate and to prioritize projects within the region. Projects are classified into categories including defense; economic development; hospitals, healthcare, and human services; quality of life; and transportation and government services. This important peer review and vetting process is used to establish project credibility, readiness, and to gauge competitiveness for external funding (e.g., congressionally directed spending, grants). I am pleased to report that Vandalia is party to two projects that were submitted for evaluation, and that both projects were approved for recommendation through the PDAC process. These projects include a request for \$400,000 for the Robinette Park splashpad, playground, restroom project. Representative Phil Plummer has already indicated to me that he is recommending that this project be funded in the State's capital budget bill. The second project includes a request for \$15,000,000 for plant improvements at the Tri-Cities North Regional Wastewater Authority – the City's joint venture with the cities of Huber Heights and Tipp City. This request is meant to capture a total request for assistance over several phases of the project between now and the completed build out in 2030 (estimated). Tri-Cities is the third largest wastewater utility in Montgomery County. US Representative Turner's office has indicated that he has included \$750,000 in the pending federal appropriations bill for this project. Our team at Tri-Cities recently met with Representative Plummer and Representative Creech to discuss the plant updates and our request for funding under the State of Ohio's \$350 million one-time strategic community investment fund. I look forward to meeting with Senator Huffman regarding both projects in the coming months as the Ohio Senate has a different timeline than the Ohio House. I have enclosed the PDAC list of approved projects.

#### **Presentations:**

**Tri-Cities North Regional Wastewater Authority (TCA) Capital Improvement Project Update -** City Manager Dan Wendt & TCA General Manager Danny Knife will give an update on the Tri-Cities North Regional Wastewater Authority (TCA) Capital Improvement Project. I have enclosed Mr. Knife's presentation.

**ESG Comprehensive Facility Plan for Maintenance and Capital Replacement -** Energy Systems Group (ESG) was commissioned to prepare a Comprehensive Facility Plan for eight buildings owned by the City of Vandalia. Keith Valiquette of Energy Systems Group and Tom Boardman of LBJ Engineering, will be presenting the Comprehensive Facility Plan (CFP) to City Council in Study Session on Monday, February 19. The intent of the CFP was to develop a tool for budgeting of future facility maintenance and capital replacements which to maintain the facilities in optimal service condition. The assessment was based upon facility and component inspection and review utilizing best industry practices at the following eight (8) facilities including the Bruce Sucher Vandalia Recreation Center, Justice Center, Municipal Building, Fire Station #1, Fire Station #2, Park Maintenance Facility, Cassel Hills Golf Course Clubhouse, and Senior Center.

The infrastructure project implemented by ESG in 2023 focused primarily on HVAC, electrical, and roofing and has advanced the City to a position of being able to perform preventative maintenance, versus reactive repairs, for the systems impacted. The CFP addresses budgeting for the next cycle of replacements for those systems but also incorporates an assessment and budgeting of facility systems and components not included in the ESG project. The reports address the following additional systems:

- Substructure (foundations)
- Superstructure (floor construction, roof structure, etc.)
- Exterior Enclosure (masonry, stucco, exterior doors, windows, insulation, etc.)
- Interiors (floor, interior finishes, hazardous materials, handicap accessibility, etc.)
- Services (plumbing, HVAC, lighting, fire alarm, etc.)
- Civil (asphalt, concrete, etc.)

The Comprehensive Facility Plan will serve as a guide to capital budgeting priorities and provide a proactive approach moving forward to ensure long-term use of our major buildings. I have enclosed a copy of the presentation that will be shared on Monday.

The recommended maintenance/improvements are categorized by when they are anticipated to be needed, broken down into the time periods shown below. The CFP can be viewed here: <u>0 2024 Facilities Improvement Plan City of Vandalia.pdf.</u>

#### Monday, March 4, 2024, Items:

Resolution: Taylor'd Firefighter Training Prop - The Division of Fire is fully committed to delivering top tier, value added services to our customers. Top tier service comes from top tier training and preparation. Like any successful sports team, "practice makes perfect," for our adult learners the best practice is practical, hands-on, repetition with "game day conditions." Being able to replicate realistic "game day" scenarios and/or conditions helps us build muscle memory which is key to developing top tier firefighters. To address these needs in the current training environment the Division of Fire has budgeted and seeks the City Council's approval to purchase a Taylor' D mobile firefighter training prop. The prop is flexible and can be set-up to allow firefighters to practice several tactical skills. The prop is compact and expandable to allow for continued growth of the Division of Fire's firefighter training program.

Resolution: 2025 Patrol Vehicles - The Division of Police is scheduled to replace two patrol vehicles in 2025 as part of the annual fleet rotations. VPD's patrol fleet is currently comprised of Ford Utility patrol vehicles, which allows for uniformity in our fleet and consistency for service and maintenance issues. It also allows us to transfer some equipment from outgoing vehicles into new patrol vehicles. Due to the ongoing demands for patrol vehicles and limited time windows for ordering patrol vehicles, VPD is seeking to order two patrol vehicles in 2024 that we hope to have delivered in late 2024 or early 2025 and are due to replace two aging 2020 Ford Utility patrol vehicles. The current pricing for 2025 Ford Utility patrol vehicles is unavailable from the manufacturer and there is no current state bid for the 2025 model year. I request Council approve waiving competitive bidding and authorize the Division of Police to purchase two 2025 Ford Utility patrol vehicles at a unit price up to \$62,150 each, not to exceed \$124,300 through Beau Townsend Ford, a local dealership who has provided exceptional and reliable service in ordering past patrol vehicles.

Resolution: Right of Way and Public Property Mowing Contract - Bids were publicly opened for the 2024-2025 Mowing & General Maintenance contract on Wednesday, February 7, 2024. This bid was coordinated with the Parks & Recreation department in an effort to receive better bid pricing. Eight (8) sets of specifications were issued, and four (4) contractors submitted acceptable bids for mowing, trimming, and litter collection in certain right-of-way (ROW) areas and City-owned parcels. Bids ranged from \$75,664.00 to \$100,806.00 for the annual mowing estimate. Director Borton recommends awarding the contract Property Worx, LLC as the lowest and best bid of \$75,664.00 for the annual mowing estimate based on bid quantity mowing frequencies.

**Resolution:** Countywide 911 Program Review Committee Appointment Distribution Of Wireless Or Enhanced 911 Service Charges – The passage of HB 33, the State's budget bill, adopted by the 135th General assembly, resulted in a revision of the Countywide 911 Program Review Committee ("Review Committee") composition beginning October 2023. The revision includes six voting members who are responsible in part for developing the countywide 911 Plan. The fifth appointee is a city councilmember selected by a majority of the municipal corporations in the county.

The Review Committee is responsible for developing a plan for distributing access fees (i.e., 40 cents per cell phone line and other qualifying devices per month) among communities with Public Safety Answering Points (PSAPs). Many communities track calls differently. Rather than base fee sharing on calls, our peer government representatives at the Miami Valley Communications Council (MVCC) have proposed basing potential revenue sharing on population. Based on Vandalia's population, the City stands to gain approximately \$27,000 per year in access fee revenues until the clause sunsets on October 1, 2025.

Members of MVCC met and recommended that Oakwood Mayor William D. Duncan be appointed to serve on the Review Committee and recommended that Centerville Mayor Brooks Compton be appointed to serve as the alternate. The appointments require legislative adoption by a majority of the municipal corporations in the county. I recommend approval of the resolution by the Vandalia City Council to make the appointments as recommended by the Miami Valley Communications Council.

Resolution: Webster Street Resurfacing Final Legislation - The City and the Ohio Department of Transportation (ODOT) have previously agreed to partner in the Resurfacing of Webster Street from Stop Eight Road to Little York Road. Final plans have been approved by ODOT and the bid letting date is set for April 4, 2024. We received Federal Surface Transportation Program funding through MVRPC for 80% of the project in an amount up to \$717,131. The original construction cost estimate including construction engineering that was in our grant application was \$896,414. We have received an invoice from ODOT for our share of the project in the amount of \$178,200. ODOT's policy is that the local sponsor (City of Vandalia) make payment to them prior to the bid opening. I am requesting that we approve a resolution authorizing the City Manager to enter into a contract with ODOT and make the payment of \$178,200 for the Webster Street Resurfacing Project Identification Number (PID) 116880. The Council has appropriated these funds in the Safe and Stable fund portion of our 2024 Capital Improvement Plan.

**Variance:** BZA 24-02 Fence Height – 4300 Little York Road - The Applicant, Mr. James Richardson has requested a variance to exceed the maximum fence height requirement in Zone B of a residential zoning district, and to have the fence not follow the natural contours of the ground for the property located at 4300 Little York Road. The Applicant has proposed adding a fence up to 13-feet in height that would not follow the natural contours of the ground. On February 14, 2024, the Board of Zoning Appeals voted 4-0 to recommend approval with one condition.

#### **Discussion Items:**

Signs in VCCO – In May of 2022 City Council passed Ordinance 22-15 creating the Vandalia City Center Overlay (VCCO) identifying certain development standards within the district. The VCCO as shown on the map, overlays multiple different underlying zoning districts. The intent of the VCCO was to have specific guidelines in this area for future development or redevelopment of these properties. One of the standards relates to signs in the overlay. The intent was for new development where the front setbacks are minimal, and that signage would be placed on the structures themselves. Our typical sign requirement in our commercial areas call for the installation of monument signs which is what many of the existing businesses in the VCCO have, thus making them non-conforming so that replacing or repairing these signs requires a variance. City Council has requested evaluation of the VCCO sign requirements, and consideration of an amendment to the VCCO sign requirements that would address the replacement of existing signs. The proposed amendments will be reviewed in the City Council Study Session prior to requesting a recommendation from the City Council to presenting the information to the Planning Commission.

**Cemetery Fees -** The City received a survey of cemetery fees comparing other local jurisdictions. The cemetery fees for Vandalia's Poplar Hill Cemetery were last modified and took effect in January 2009 but were not substantially changed since 1999. After reviewing and comparing our cemetery fees to thirty-three (33) other local jurisdictions, Director Borton has made some recommendations relating to cemetery fees. The purpose of the adjustment would be to better cover the City's actual costs for these services, as personnel, equipment, and material costs as they have increased since the last rate adjustments in 1999 and 2008. The proposals include leaving the lot prices the same, while maintaining other fees that will be at or near the average cost of the other jurisdictions.

Resolution 24-R-10: Removal & Replacement of Certain Curbs and Sidewalk – Bids were publicly opened for the Removal and Replacement of Certain Curbs and Sidewalk on Tuesday, January 30, 2024. Ten (10) sets of specifications were issued, and seven (7) contractors submitted acceptable bids for the project. Bids ranged from \$277,592.00 to \$538,539.00. I recommend awarding the contract for this project to Coate Construction LLC as the lowest and best bid at their bid price of \$277,592.00.

Resolution 24-R-11: Land Use Permit with Miami Conservancy District for Bikeway Project - The Vandalia Bikeway connector project is nearing the final stages before the project is scheduled to sell by the Ohio Department of Transportation (ODOT) in May of 2024. A portion of the Bikeway will be located on land owned by the Miami Conservancy District. They have been involved in the planning and approval process of the project from the beginning and are in support of the project. As a last step to satisfy the requirements for us to install, use and maintain the bikeway that will be located on conservancy land, the City must submit the attached Land Use Permit and pay the \$150 administrative fee. Per the permit, we also required to carry commercial liability insurance that names Miami Conservancy District as additional insured. I am recommending the passage of a resolution that would authorize the City Manager to submit the permit on behalf of the City.

Under the direction of the City Manager, the leadership team executes the policy directives of the Vandalia City Council including the day-to-day operations of police, fire, emergency medical services, and dispatch; water distribution, wastewater collection, and storm water utilities; public works and street construction; economic development, building and zoning, planning, and engineering services; and community enrichment through the Vandalia Recreation Center, Senior Center, Cassel Hills Golf Course, Cassel Hills Swimming Pool, and numerous parks.

# **COMMAND STRUCTURE**



#### **DIVISION OF POLICE**

The Vandalia Division of Police prides itself on being in touch with the community and providing exceptional customer service. The Vandalia Division of Police headquarters is located at 245 James Bohanan Drive in the Vandalia Justice Center and operates an award-winning communications center, which the community has come to rely on for fast, professional and courteous service.

The Vandalia Division of Police is one of a small number of Ohio police agencies accredited by The Commission on Accreditation for Law Enforcement Agencies.

The Division of Police has as its mission the protection of life and property and the promotion of a safe and secure environment, in a manner that is consistent with community expectations. Mission achievement strategies include: Crime Prevention and Suppression; Order Maintenance; Detection and Apprehension of Law Violators; Recovery of Lost and Stolen Property; Promotion of Community Support, Cooperation and Goodwill.

The Vandalia Division of Police is dedicated to effective and efficient operation; fair and impartial application of laws; courteous, professional and ethical conduct; and the professional development of its personnel. Vandalia police personnel shall respect and protect the rights of individuals and perform their services with honesty, zeal, courage, discretion, fidelity, competency, and sound judgment.

#### THE POSITION - THE IDEAL CANDIDATE - THE QUALIFICATIONS

#### QUALIFICATIONS:

Must be a US Citizen at least 21 years of age. Completion of secondary education or equivalent (high school diploma or GED), Associate's degree preferred; at least six (6) months of related experience preferred; or any equivalent combination of education, experience, and training which provides the required knowledge, skills, and abilities. Must be able to pass a police background investigation for employment and must be eligible to be LEADS certified. Must be able to work rotating shifts, nights, overtime, weekends, and holidays.

#### LICENSURE OR CERTIFICATION REQUIREMENTS:

OPOTA basic peace officer certification must be obtained prior to appointment. Must possess a valid driver's license and must remain insurable under the City's vehicle insurance plan.

A major responsibility of government is to provide services which enhance the quality of life for its citizens. As a unit of municipal government, the Division of Police has as its mission the protection of life and property and the promotion of a safe and secure environment, in a manner that is consistent with community expectations.

- Protects life and property through the enforcement of laws & regulations
- Proactively patrols assigned areas
- Responds to calls for police service
- Conducts preliminary & follow-up criminal and traffic investigations
- Conducts interviews
- Prepares written reports & field notes of investigations and patrol activities
- Arrests and processes criminals
- Testifies in court
- Emergency duties required during adverse weather conditions
- Ability to exercise judgment in determining when to use force and to what degree
- Operate a law enforcement vehicle under emergency conditions day or night
- Comprehends legal documents including citations, affidavits, warrants and other documents
- Commands emergency personnel at accident emergencies and disasters
- Takes an active role in Community Oriented Policing
- Self-initiate traffic and / or crimnal investigations
