Income Tax receipts, net of refunds, are up .27% through July compared to last year. We continue to exceed gross budgeted income tax revenue by over 10%.



Overall Income tax receipts (\$12,929,435) are down YTD by .15% (-\$19,361) over July 2023. Withholding tax is up 1.12% YTD (\$108,702); Individual tax is up 2.57% YTD (\$31,323); Business net profit tax is down 7.73% YTD (-\$159,386). Refunds issued YTD were \$464,592.77. Overall receipts, net of refunds, were up .27% as compared to July 2023, also net of refunds.

The amount of income tax revenue budgeted for 2024 is \$19,671,000 (\$1,639,250/month * 7 months = \$11,474,750). The amount collected YTD is \$12,929,435. Therefore, the amount collected through July is 12.68% higher than the estimated amount based on the budget.

- 2. I attended a Northern Area Water Authority Board meeting where I presented the June YTD financial report.
- 3. I participated in both the pre and post pricing calls and process for the sale of the Bond Anticipation Notes in preparation for the closing and wiring of funds on August 20th. Due to volatility in the market earlier this week, and with the assistance of bond counsel, the Underwriting team went out to the market a day earlier than planned and was able to secure a favorable interest rate of 4.875%. The Notes include the debt service for the fire engine, new ladder truck and apparatus.
- 4. The compilation team and auditors from Plattenburg and Associates completed the 2023 audits and annual reports. We received notification from the Auditor of State's Office that the 2023 audits for the City of Vandalia, Tri-Cities and NAWA were accepted and require no modifications.
- 5. The Land Acquisition Note issued for the acquisition of land for the Stonequarry Crossing development will mature on July 24, 2024. **This issuance scheduled and budgeted is a renewal of existing debt, and NOT an issuance of new debt.** The total amount due is \$1,399,000 in principal plus interest. The maturity date on the new

- note (\$1,399,000) will be in July of 2025. The debt is scheduled to be paid in full in 2036.
- 6. The 2025 Proposed Budget workbooks have been emailed to the departments. Budget season has begun!
- 7. I attended an informational/financial meeting regarding EV chargers.
- 8. Kristen, Nina and I met with members from Parks & Rec to discuss current processes and options to streamline and develop new daily/monthly transaction and interfacing processes.
- 9. I attended a final concept meeting for the Public Works Facility that included an update on the design and total costs to date.
- 10. Kristen and I met with the City's PNC Bank representative to discuss ACH limits, current processes and options to streamline to reduce time and costs.
- 11. I met with members from CMO to discuss various personnel issues and payroll processes.
- 12. Kristen and I met with members from CMO to discuss an overview of the 2025 Proposed Budget and Financial Report presentation.

FACILITY MAINTENANCE DIVISION

- The first and second round interviews, as well as a practical assessment, were completed for the vacant Building Maintenance Technician position. We anticipate an offer of employment being made early next week to the top candidate.
- Building Maintenance staff are working with contractors at the VRC Aquatic Center on several projects taking place during the annual maintenance and cleaning shutdown period. Worked with the Division of Fire to conduct confined space training for three days during the shutdown period.
- Landscape maintenance projects are taking place at various locations including the Recreation Center, Seger Park, Senior Center, and Downtown Streetscape. Work includes weed control, tree work and mulching.
- The contractor is onsite at the Senior Center performing exterior maintenance to the building including power washing, tuck point repairs, caulking, painting, and sealing of brick surfaces.
- Park Maintenance staff are in the process of removing excess soil around the new park sign locations. The soil removed is being used onsite for soil grade improvements at those locations (Cemetery, Art Park, Helke Park).
- Helke Park Tennis and Pickleball Court resurfacing work continues. Crews have completed work on the six tennis courts and are currently working on the pickleball courts. We anticipate the pickleball courts to reopen for play later this week.

RECREATION / ATHLETICS DIVISION / SPECIAL EVENTS

- The Schellas Hyndman Soccer Camp took place July 15-19 at the Sports Complex. We had a total of 76 youngsters participating in the camp. Schellas once again donated his time to organize and oversee the week-long camp with all proceeds going to the Vandalia Recreation Fund of the Dayton Foundation. Beau Townsend Ford and the Vandalia-Butler Optimist Club provided financial sponsorship of the camp t-shirts and other expenses.
- o Twin Night at Art Park: This event happened on Thursday, July 18 from 7pm-9pm at Vandalia Art Park. Spittin' Image provided the music performance, with over 100 people in attendance.
- Summer Splashtacular: This event happened on Friday, July 19 from 11am-2pm at the Vandalia Sports Complex. There were many water-themed games for people to enjoy, from water slides, balloon fights and more. We had several hundred people come out to enjoy this

- event. We are very grateful for our partnership with the Division of Fire to put on this great event.
- Frozen Party in the Park: This event happened on Thursday, July 25 from 6:00pm-7:30pm at Vandalia Art Park. The event had music and dance performances themed around the Frozen movie series. There were around 400 people at this event.
- Campfire Story Night: This program happened on Tuesday, July 30 from 7pm-8pm at the Vandalia Sports Complex. Participants enjoyed stories from the Dayton Metro Library and made s'mores after. We had 66 people sign up for this program.
- Youth Soccer is underway as teams have been formed and practices are taking place at the Sports Complex. Games will begin on August 17. The Passers, Wings, and Striker divisions will be playing in a league with Englewood, Huber Heights, and Tecumseh.
- Registration continues for our NFL Youth Flag Football program. Currently we have 138 kids registered to play. Teams will be formed in the coming weeks and games will begin Sunday, September 8 at the Sports Complex.
- Pickleball continues to grow in Vandalia. The courts at Helke Park typically have an overflow
 of players waiting for a court to open during evening hours. Often times, players will move to
 the tennis courts to play until a court opens. We have also noticed a large influx of middle and
 high school aged players using the courts, which is awesome to see.

RECREATION CENTER

- We are in the middle of our Aquatic Center Annual Maintenance Shutdown period. We have several maintenance projects taking place during the shutdown period including painting of the ceiling and support beams above the pool. The paint in these areas is original to the building and overdue for a fresh coat of paint. There are also several plumbing and mechanical projects taking place along with a deep cleaning of the facility. The pool will reopen on Saturday, August 17.
- Daily Admissions for the month of June totaled \$29,570, which is over \$10,000 higher than June of 2023 and \$8,000 higher than our 5-year average for June. VRC membership monthly electronic fund transfer for July totaled \$20,517, which is up by \$1624 over July of 2023.
- Administrative Coordinator Sharon Hamby is working with Rich Hopkins to complete a VRC Corporate Incentive brochure. When finalized, Sharon and Aaron Messenger will develop a plan to get the information distributed to existing corporate members as well as potential new ones.
- Our Recreation Coordinator for Programs and Special Events has been advertised in the National Recreation & Parks Job Bulletin online as well as the Ohio Parks & Recreation Association Job Bulletin. The application deadline is Monday, August 19.

GOLF DIVISION

- I am happy to share that Assistant Golf Superintendent Tim Bailey returned to work on the 29th of July. Tim was in a serious motorcycle accident earlier this summer and was off several months recovering from his injuries. Welcome back Tim!
- The Vandalia-Butler Chamber of Commerce Annual Golf Outing took place on August 6 at Cassel Hills Golf Course. A total of 81 golfers supported the Chamber by participating.
- Play continues to be strong when the weather is not super-hot. 300 golfers played last weekend. We anticipate good numbers for the rest of this week and the weekend as well.

- 1. During the past two-and-a-half weeks, VPD officers made 27 traffic stops on commercial motor vehicles for traffic violations. These stops resulted in two traffic citations, 17 written warnings and eight verbal warnings while working 20 additional enforcement hours.
- 2. On July 22, Vandalia Police sponsored the annual blood drive put on by Solvita. We had a good turnout and thank everyone who gave blood.
- 3. Lieutenant Walker, Sergeant Nagel, and Officer Blackford met with representatives from Kettering Health Network (KHN) Sports Medicine on Wednesday, July 24. VPD is looking to partner with a sports medicine network to provide our employees with access to a physical trainer for advice on improving physical health through fitness and nutrition. KHN's program is tailored for public safety and would provide monthly visits and consultations with a physical trainer. The program also includes health and wellness presentations and personalized nutrition/workout plans. At the end of the year, KHN provides a report with estimated savings in healthcare or treatment costs based on the consultations they provided through their program.
- 4. On July 24, Lieutenant Walker and Lieutenant Sucher attended the graduation for prospective police officer recruits Zachary Landis and Tyler Cayot from the Sinclair Police Academy. They both passed their state certification exams and will soon be ready to start their new careers with VPD.



- 5. Accreditation Manager Shannon Green attended the Commission on Accreditation for Law Enforcement Agencies, Inc. (CALEA) conference in Winston-Salem, North Carolina, July 23-27. During the conference, she attended courses on developing Continuity of Operations plans, preparing an analysis, compiling statistics for the division using CALEA's Information Management & Reporting System (CIMRS), as well as attending the reaccreditation reviews of some peer agencies within Ohio.
- 6. On July 26, VPD responded to two injury traffic crashes involving vehicles that rolled over after crashing. In the first crash, a 36-year-old Vandalia man was traveling southbound on Dixie Drive when he ran over the curb and struck a utility pole, knocking the pole down in the roadway. The vehicle rolled over onto its top; however, the driver was not injured. The roadway was closed while crews cleared the debris. The second crash involved a 69-year-old Vandalia woman who experienced a health event while traveling northbound on South Brown School Road. She ran off the right side of the roadway and struck a utility pole, knocking it down in the roadway. Her vehicle also rolled onto its top. She was transported to the hospital with non-life-threatening injuries. AES was able to replace both utility poles that same evening.
- 7. On July 29, Lieutenant Walker attended the virtual Crisis Intervention Team (CIT) Steering Committee meeting hosted by Montgomery County ADAMHS. Topics discussed during the meeting included CIT role-specific Probation/Parol officers, Ohio CIT data, third quarter and fourth quarter CIT awards, and feedback on various materials ADAMHS provides to law enforcement.
- 8. During the week of July 29, Lieutenant Walker and CPO Sommer participated in several inspections of the Super 8 hotel with VFD and DES. Management addressed a few outstanding issues during the week and was granted their City license to reopen on August 5. The hotel has been closed since last July after a structure fire caused significant damage.
- 9. On August 2, Officer Sommer spoke to the kids at Early Beginning's Learning Center. The presentation was on stranger danger, water safety, gun safety, and dealing with stray animals.
- 10. VPD's annual National Night Out event was held on August 6 at the Sports Complex. This year's activities included hayrides, police K-9 demonstrations by Dayton Airport Police, police vehicles, corn hole, face-painting, balloon cartoons, DJ music/dancing, free food, fire department vehicles, and bike rodeo. We had some new partnerships this year with Montgomery County CARE House, Girl Scouts, and the Vandalia Library. We thank all of those involved and the local businesses who made the event possible. The heat and threat of severe weather kept our attendance from reaching the record-setting level of last year; however, we still had a great turnout. This community event is a great way for officers and the community to have positive interactions. Each year, we seek ways to improve over the previous years to keep in line with the City's goals and objectives and these improvements continue to grow the event.





- 11. On Thursday, VPD held another meeting with local hotel management to discuss trends and crimes occurring at these establishments. The Division holds these quarterly meetings with our hotels to foster cooperation, reduce crime, and provide resources needed to combat crime and nuisance issues. Lieutenant Walker, Sergeant Garry Lawson, VFD representatives, and DES covered topics related to criminal trespassing and the upcoming licensing and inspection process in the fourth quarter of 2024.
- 12. Detectives charged a 40-year-old man with Aggravated Drug Possession (Methamphetamines). The suspect had possession of drugs in his pocket and was incarcerated at the Montgomery County Jail on an active misdemeanor warrant
- 13. Detectives charged a 31-year-old Dayton man with Possession of Drugs (Cocaine), OVI (Cocaine), OVI (Marijuana), and Child Endangering. The suspect was driving when he crashed and overdosed with a child in the backseat. The suspect was transported to the hospital.
- 14. Detectives charged a 31-year-old Vandalia man with Harassment by Inmate and Resisting Arrest. The suspect spit on a VPD officer and resisted arrest during a traffic stop and was incarcerated at the Montgomery County Jail.
- 15. On Saturday, we will host our annual police retirees' firearms qualification at the Montgomery County Sheriff's Officer Range. This annual qualification allows us to interact with our retired officers and gives them the opportunity to meet state standards for firearms qualifications.

Development & Engineering Services (DES)

Dog Leg Water and Sanitary Extension Phase 2 project update: Fabrication of the sanitary sewer lift station has been delayed and is now expected to arrive at site in October 2024. Outdoor Enterprise is now expecting to remobilize back to site in October 2024 to complete the remaining work.

A pre-construction meeting was held on July 22nd for the Vandalia Bikeway Connector project. The contractor, Brumbaugh Construction, plans to start work around November 4th with focusing efforts at the Taylorsville Dam first.

While the City's EV charging stations are still waiting on AES service connections, DES and Finance staff have been corresponding with Blink (the EV charging service the City's charging stations will operate through based on the grant the City received) to get the necessary legislation ready and approved to operate the stations.

The Municipal Building generator has been installed, tested, and in operation. The old generator has been removed. A big thanks goes out to Electrical/Building Inspector Martin for his work on this project.

Super 8 has received a new Certificate of Occupancy (CO) and Hotel/Motel Registration.

A new CO was issued to Helke Elementary School for the added classrooms.

Building and electrical permits have been issued for TCA's Taylorsville Equalization Improvements project located in Taylorsville MetroPark.

We held our monthly department staff meeting on July 26th.

Assistant City Manager Cron, Chief Building Official Mastrino, Public Works Superintendent Hayslett, IT Manager Davey, Finance Director Leiter, you, and I met with WDC Group on July 31st to discuss the current layout for the proposed new Public Works facility and value engineering ideas.

Assistant City Manager Cron, Finance Director Leiter, you, and I attended the monthly NAWA Board meeting on July 25th.

Public Works (PW)

Crews continued inspecting sanitary sewer lines with the Sewer Line Rapid Assessment Tool (SL-RAT). This tool gives our personnel a rating between 0-10 on how clogged the sewer main is between two (2) manholes (MH). Crews cleaned 11 spans found to have a score of 4 or below using the Vac truck; this preventative maintenance avoided sewer clogs at those locations.

Crews excavated and laid asphalt repairs for bad sections of roadway found after asphalt milling from the 2024 Street Resurfacing project. These repairs will help make the newly resurfaced streets hold up better before needing to be resurfaced again.

Crews continued installing water meters across the City as part of the meter replacement multi-year project. Some meter replacements required replacements of leaking angle valves and hydro-excavating of curb boxes.

These leaking angle valves are located on the City side of the water meters, so residents and business owners are not being charged for this leaking water usage.

As part of EPA annual requirements, crews operated more watermain values to confirm their functionality in case the values are needed to isolate a watermain break and affect less residents.

Crews completed spraying vegetation growth in the curb/gutters.

Utility Service Company performed a complete washout and inspection of the Sports Complex water tower, per our contract schedule.

Three (3) of our newer personnel went to Confined Space training.

Crews installed banners for Purple Heart City; Purple Heart Day was August 7th.

Crews performed 113 utility locates this period for Ohio 811.

Crews performed 2 burials at Poplar Hill cemetery during this period.

The mechanics fixed our Trackless (used for Right-of-Way brush trimming/mowing and leaf collection), serviced the street sweeper replacing numerous parts for preventative maintenance, helped the Golf Course by working on their mowers, and worked on Fire Division truck 3's exhaust. By performing this work in-house, our mechanics save the Public Works Division and the City money.

We completed second round interviews for full-time Public Works Technician. Civil Service Commission meeting is scheduled for August 12th before we can send out a conditional offer to fill the vacant position. The remaining candidates will be kept on an eligibility list in an effort to keep our crew fully staffed moving forward.
