Last Thursday, we had the Ribbon Cutting for the Vandalia Bikeway Connector project at Taylorsville MetroPark. While the weather was not the greatest, it was still a great day for Vandalia to now have this connection to the Great Miami River Trail. Contractors are continuing to address punch list items as the project nears completion. With the warmer weather this week, A&A Safety is hoping to complete the remaining permanent pavement markings. Security Fence finished installing the vandal-protection fencing on the new bridge, roadway delineators along S.



Brown School Road, and is working on the remaining signage throughout the project. This project took several years and a lot of effort and cooperation between many organizations and people. Thanks to all our dedicated staff who put in many hours to see this project become reality.

On Saturday, October 25, we hosted the Halloween Hangout at the Vandalia Sports Complex from 11:00am-2:00pm. There were food trucks, hayrides, Trick-or-Treating, inflatables, kid's activities, Halloween costume judging, craft vendors, and more! This event had a steady crowd the entire time and over 1,000 people attended this event.

On October 28, Police Captains Walker and Krimm, Chief Sucher, and I attended the MVRMA Law Enforcement Legal Update hosted by the Miamisburg Police Department which covered case law surrounding litigation, the importance of documenting police actions taken during investigation, and recent case law.

On October 29, we hosted a Records Commission meeting in the Municipal Building's Large Conference Room to review and discuss any changes to our records retention policy and schedule. Representatives from various city departments attended to offer input and make recommendations.



Last Wednesday, I had the opportunity to attend the Career Adventures Day at the Dayton Metro Library Main Branch in downtown Dayton where they hosted various businesses and organizations who provided hands-on demonstrations and shared valuable information on career opportunities to students from across the Miami Valley. I enjoyed interreacting with students from



Morton Middle School and speaking with several local business representatives, including Inteva Products and PSA Airlines.





The Cassel Hills Golf Course irrigation project is completed. The contractor finished up Friday, October 31<sup>st</sup>. They will be back later in the month to blow the system out and will be back in the spring to check on the system as it goes into full operation for 2026. Golf staff is happy with the project, and in the end, it had little impact on golf course play.

On October 31, the City hosted an annual review of the City's Emergency Operations Plan at the Senior Citizen Center for key staff members and departments directors. Thanks to Chief Follick for organizing and presenting an overview of the EOP and keeping staff appraised of plans in case of an emergency or hazard situation.

Our staff from the Police & Fire Division's were busy last week attending several trunk-or-treat events throughout the city, including at St. Christopher's Church and Helke Elementary, as well as participating in Beggars Night with extra patrols in the neighborhoods to pass out candy and greets the trick-or-treaters who were canvassing the area in search of candy.



The South Dixie Drive water main break on the 12" trunk main has been repaired. Crews backfilled the hole, installed a new CB & storm, poured concrete for the curb, placed new asphalt in the roadway, and placed new topsoil in the tree lawn. All work for this main break is now completed, and the roadway is back open to all traffic lanes.

On November 7, Chief Sucher and Captain Walker attended the graduation ceremony for Captain Krimm and Sergeant Wehner who completed the Supervisors Training and Education (STEP) Program. STEP is a three-month leadership program with 13 days of in-person training hosted by the OACP Law Enforcement Foundation. This is the beginning of a three-phase program which includes the Police Executive Leadership College and the Certified Law Enforcement Executive program.



Fire Captain Copp presented a local organization, Breast Wishes, with a donation check from the Fire Division's annual t-shirt fundraiser on November 3<sup>rd</sup>. Special thanks to the FD staff who raised these funds to support cancer awareness month.

During the past two weeks, VPD officers made 10 traffic stops on commercial motor vehicles for traffic violations. These stops resulted in two traffic citations and eight written warnings while regular patrol enforcement hours.

This past Thursday we had the Ribbon Cutting for the Vandalia Bikeway Connector project. While the weather was not the greatest, it was still a great day for Vandalia to now have this connection to the Great Miami River Trail. This project took several years and a lot of effort and cooperation between many organizations and people.



- You and I spoke with our lobbyist at Highbridge Consulting to review the PDAC application and the next steps in our request for funding from the 2026 State Capital Budget for our new Public Works Facility.
- We had a meeting with our architect, WDC Group, for the Public Works Facility. We are at the 90% design stage with just a few more details to iron out. Their consultant is still working with the Army Corps regarding the stream crossing along Northwoods Boulevard that will be the entrance to the facility. This had been a lengthy process and once resolved, the culvert and entrance drive will be put out to bid.

- Ben Borton and I met with Montgomery County Engineer's representatives and our Right of Way consultant for the "Ring Road" project. Offers have been sent to over 40 property owners along the project where acquisition will be required. Seven of those parcels are in Vandalia.
- Thank you to Chief Follick for providing a citywide Emergency Operations Plan update to all of the key personnel involved in our Emergency Operations activities.
- We have received a Vandalia Development Corporation application for assistance from a current local business that is looking to relocate and expand with Vandalia. We have a meeting scheduled for next Wednesday to consider their request.
- Gabe Newberg from the Dayton Development Coalition and I held a Business Retention and Expansion meeting with staff from E-Mek Technologies at 7410 Webster Street. E-Mek manufactures circuit boards at this location and serves a variety of companies with their products. They currently lease about 60,000 square feet of the facility at 7410 Webster Street and employ 60+ full-time employees.
- I attended the Miami Valley Regional Planning Commission Board of Director meeting on Thursday, November 6.
- Bridgette Leiter and I had a phone interview with a local resident who is a journalism student at Ohio University. She was interested in writing a story for a project on our utility rate increases.
- The Planning Commission will have five items on their November 11 meeting agenda.
  - 1. PUD Amendment for Flying J to allow an EV Charging Canopy
  - 2. Record Plan for Stonequarry Crossings Section 15 9085 Peters Pike
  - 3. Conditional Use at 9805 Peters Pike for Warehouse Use

  - 5. Code Amendment amending the Thoroughfare Plan for the City
- The Board of Zoning Appeals has three items on their November 12 meeting agenda.
  - 1. A variance to allow chickens at 411 Birdsong
  - 2. A variance to the maximum Retail Floor Area at 9375 N. Dixie Drive
  - 3. A variance to the front yard setback at 112 Gabriel Steet
- The Block Party Trailer season is over this year. The trailer was utilized seventeen times in 2025.
- Final edits have been made to the next edition of the MyVandalia Magazine. This edition was expanded a bit to include the info graphics that were discussed during our budget workshop regarding our utility systems. This edition should hit mailboxes around the end of November.



#### "Movember" is to Men's Health

Movember is an annual health awareness campaign held in November that focuses on men's emotional and physical health—and on raising awareness about issues men often avoid like prostate and testicular cancer screening, and mental health. It began in Australia and involved growing a mustache ("mo") as a campaign idea, but its message is universal: Break the stigma of prevention screening and early treatment. Reaching out for professional help isn't easy, especially when you've learned to stay tough and keep things private. But mental health challenges can affect anyone, even the strongest. (Even Navy SEALs have access to mental health resources—and are encouraged to use them.) Many men recognize they need help but talk themselves out of it. "I should handle this alone." "People will find out." "It's not that bad yet." Delaying help can make things worse and limit options later. Stress, conflict, burnout, relationship issues—handling these alone isn't strength. Real guts is knowing when to make the call and get free, confidential help that keeps you in the game.

## Handle Workplace Conflict with the 24-Hour Rule

If conflict is normal, it makes sense to use personal strategies to help you stay above the fray. Here's one to try: The 24-Hour Rule. When a coworker's comment or email triggers you, resist the urge to react. Wait 24 hours before responding. Step away, take a walk, and focus on something else—put time between you and the spat. During this pause, emotions cool and rational thinking returns. What felt urgent yesterday often seems manageable today. This delay prevents impulsive reactions that damage relationships or escalate tension. The 24-Hour Rule isn't about avoiding conflict—it's about managing it with clarity rather than emotion. The payoff is peace of mind and a reputation for calm and thoughtful professionalism.



## **Productivity Tip: Use the Rule of Three**

The "Rule of Three" is a simple productivity strategy where you focus on only three main tasks or goals each day to maximize success. This strategy helps reduce overwhelm while increasing true progress. At the start of your day, choose three priorities. This narrows your focus, prevents mental fatigue from scattered to-do lists, and keeps you from being pushed and pulled by interruptions. Whether you finish all three or struggle to complete any, daily practice trains your mind to prioritize naturally, tune out distractions, and focus on high-value tasks. Small wins become frequent, you feel more in control of your days, and productivity grows dramatically. In fact, you'll achieve more than you expect consistently with less stress. That's the power of the Rule of Three. Source: J.D. Meier, "Getting Results the Agile Way".

## **Stress-Proof Your Day**

"Stress-proofing" your day ensures that you stay focused on what's within your control and maintain a positive mindset. No matter the stress—setbacks, workload, office frustrations—start by noticing small wins, such as completed tasks, a positive conversation, kudos from a supervisor. Let these successes define your attitude. Look for the hidden gain in challenges. "What can I learn from this?" or "How can I turn this into an opportunity?" This is called "reframing the pain" and it works. Turning these tactics into new reflexes to respond to stress will lead you to enjoy your job more. When small positives happen, express internal gratitude. This behavior strengthens resilience and naturally reduces negative reactions to normal stress. A last word about perfection: Seek to do outstanding work, not perfectionism. The two are different—the latter undermines your energy, focus, creativity, and positivity.

## Seeking Couples Counseling Help Doesn't Mean Failure

Many couples view counseling or marital therapy as a last resort, but it's one of the healthiest steps to strengthen a relationship. The truth is, even happy couples benefit from counseling. Counseling can be enjoyable, helping couples rediscover each other, improve communication, and celebrate what works. Research from the American Association for Marriage and Family Therapy shows that 60%–80% of couples experience measurable improvement after counseling, and 70%–90% could benefit from structured enrichment experiences. Options range from seminars to weeklong retreats, all providing a safe space to understand emotional needs, resolve small issues before they grow, and learn ways to build trust and deepen connection. Counseling is not about proving a partner wrong. Entering counseling with that goal as a key motivator usually leads to frustration, whereas focusing on understanding, communication, and shared growth creates lasting positive change. Like regular checkups for your health, relationship check-ins preserve emotional wellness. Seeking help early can prevent resentment, reduce stress, and increase satisfaction. Strong, healthy relationships benefit not just you and your partner, but also your overall well-being at home and work. Talk to your EAP about marital and couples' resources or search for reputable couples growth workshops and intensives to explore opportunities for strengthening your partnership.

## 7 Signs Your College Student May Be Struggling

How is your child doing in college? If they're away, it can be hard to know. Being away can be exciting but also isolating, overwhelming, and emotionally challenging. Watch for these signs: 1) Less communication—prolonged or sudden withdrawal may signal stress or homesickness; 2) Mood changes—irritability, sadness, or anxiety; 3) Academic concerns—mentions of falling behind or struggling; 4) Neglecting daily routines—skipped meals, poor sleep, or declining selfcare; 5) Loss of interest—less talk about friends, activities, or hobbies; 6) Risky behaviors—excessive drinking, drugs, or unsafe choices; 7) Expressions of hopelessness—feeling overwhelmed or trapped. If you notice these, reach out with empathy, encourage campus or professional counseling, and maintain supportive communication. - 1. During the past two weeks, VPD officers made 10 traffic stops on commercial motor vehicles for traffic violations. These stops resulted in two traffic citations and eight written warnings while regular patrol enforcement hours.
- 2. On October 27, VPD supervisory staff met with VFD to discuss updated procedures related to fire and EMS dispatching.
- 3. On October 28, Officer Sommer presented two *Run Hide Fight* classes to the students at Creative Images.
- 4. Captains Walker and Krimm and I attended the MVRMA Law Enforcement Legal Update hosted by the Miamisburg Police Department on October 28.
- 5. Officer Burmeister participated in a "Trunk or Treat" at St. Christopher's Church on October 28.



- 6. CPO Rich Sommer assisted with the Knights Inn inspection on October 29. The inspection was to obtain their operating license application through the City.
- 7. Captains Walker, Krimm, and I attended the monthly Montgomery County Chief's Association meeting at Sinclair Community College on October 29. The guest speaker was from Sinclair and the topic was Ohio's TechCred program which reimburses businesses and organizations for technology-focused credentials. Sinclair offers a number of courses that qualify for this program including UAS (drone) programs.

- 8. On October 30, Captain Krimm and I participated in second round interviews for the Public Safety Specialist hiring process. Two conditional offers were given as part of this process.
- 9. On October 31, VPD staff attended the citywide EOP revision meeting hosted by Chief Follick.

## **Development & Engineering Services (DES)**

Vandalia Bikeway Connector project: Despite the wet conditions, the ribbon-cutting ceremony for this project went smoothly on October 30<sup>th</sup>. Contractors are continuing to address punch list items as the project nears completion. With the warmer weather this week, A&A Safety is hoping to complete the remaining permanent pavement markings. Security Fence finished installing the vandal-protection fencing on the new bridge, roadway delineators along S. Brown School Road, and is working on the remaining signage throughout the project.





<u>Damian, Soter, Romanus, Desales (DSRD) Watermain Replacement project</u>: CG Construction has completed the concrete work and plans to finish the tree lawn restoration by the end of next week. Roadway milling is scheduled for Monday (11/10), followed by placement of the new asphalt surface course on the following Monday (11/17) by Barrett Paving Materials.

Updates from sites inspected or reviewed by DES staff:

- Lion Apparel building (7200 Poe Ave): Certificate of Occupancy (CO) issued from flood damage repairs
- Beau Lincoln (55 Foley Dr): permit issued for tenant upfit

Assistant City Manager (ACM) Cron and I attended the Dayton International Airport Northeast Logistics Access ("Ring Road") project's monthly right-of-way (ROW) acquisition status meeting October 27<sup>th</sup>.

ACM Cron, City Planner Hammes, Zoning Coordinator Graham, and I attended the Planning Commission meeting on October 28<sup>th</sup> for the Riverdale Section 1 Final PUD Plan.

Staff met to discuss 2026 projects/scheduling and reviewed/updated priorities of upcoming water main replacement projects in light of the S Dixie Dr 12" trunk main break.

Public Works (PW) Superintendent Hayslett, PW Office Manager Sparks, Administrative Assistant Budich, and I attended the Records Commission meeting with other City staff.

I attended Ohio Public Works Commission (OPWC) District 4 state fiscal year 2027 funding application scoring meeting on November 5<sup>th</sup>. The City submitted the Pool and Randler (N) Ave Watermain Replacement project for \$500,000 in funding.

#### Northern Area Water Authority (NAWA) – water supply treatment:

PW Assistant Superintendent Fulton and I attended the monthly technical committee meeting and Outfall Channel project review meeting for the plant's new outfall to the Great Miami River on November 5<sup>th</sup>.

#### Public Works (PW)

#### New Public Works Facility (810 Northwoods Blvd):

City staff met with WDC Group on October 27th to review the 90% construction drawings.

#### Streets:

Crews laid asphalt millings on the berm/pull-off on Old Springfield Rd by the Great Miami River to protect the edge of new asphalt from breaking.

#### Storm Sewer:

Crews rebuilt the deteriorating front wall of a catch basin (CB) at the intersection of Bristol Dr and E National Rd.

Crews continued collecting leaves as part of our annual leaf collection season and continued street sweeping curb gutters throughout the City.

#### Water:

S Dixie Dr 12" trunk main repair: Crews backfilled the hole, installed a new CB & storm, poured concrete for the curb, placed new asphalt in the roadway, and placed new topsoil in the tree lawn. All work for this main break is now completed, and the roadway is back open to all traffic lanes.

Crews installed a new breakaway kit on the fire hydrant hit in a car accident at Kenbrook Dr and S Perry St.

Crews continued installing new water meters inside residences/businesses and outside in meter pits.

#### Sanitary Sewer:

Crews cleaned the sanitary sewer main on Hartshorn Dr and had TCA/Veolia camera a span for inspection.

#### Other Services:

Crews hydro-excavated and removed the old tree root balls on E National Rd, east of I-75, thanks to the help from the Parks & Recreation Department as part of the joint effort project to replace these street trees this Autumn/Winter. Crews also installed new electrical conduit for these tree pit locations.

Crews began installing Christmas lighting on the existing street trees through the National Rd downtown area.

Crews performed 1 burial at Poplar Hill Cemetery during this period.

Crews responded and marked for 42 utility locate tickets this period for Ohio 811.

#### Vehicle Maintenance:

The mechanics completed the following maintenance and repair tasks:

- Replaced the windshield wiper switch assembly on main break box van
- Replaced a water valve, welded a fitting, and replaced a water hose & fittings on the hydro-excavator/vacuum truck.
- Replaced the ignition switch on the E-50 mini-excavator
- Replaced the windshield wiper on the E-35 mini-excavator
- Cleaned and sealed the leaking hydraulic tank on the single-axle dump truck #20
- Serviced one-ton dump truck #19 and light/sign truck #34
- Repaired and inspected Fire Division's Engine 2



#### **CALLS FOR SERVICE**

The Division of Fire responded on <u>339</u> calls for service in October (<u>234</u> EMS calls and <u>105</u> fire calls). An average of approximately eleven <u>11</u> calls for service per day.




**Note:** After ten (10) months the Division of Fire has responded to a total of **3338** calls for service. This is approximately **130** (+4%) more calls for service than we responded to in the same timeframe (end of October in 2024.

**Overlapping Call Volume:** A statistic that we can track now is how many of our calls for service overlapped (or occurred simultaneously) during this evaluation period. In October, approximately **31%** of the call volume overlapped. This is among the lowest number of overlapping calls we have experienced in several years.

Crews responded to <u>339</u> calls for service in October, the chart below outlines call types:

The Major Incident Types in October were (%) of the total call volume/month):

1. Rescue & Emergency Medical Calls (69%) - All the Division of Fire Emergency Medical calls, including any motor vehicle/pedestrian accident (with/without injuries) and/or any technical rescue response.



- 2. Good Intent Calls (14%) Smoke scares, steam/fog mistaken for smoke, false alarms not malicious.
- 3. Customer Service Calls (8%) These are calls for service where fire crews are directly assisting a customer with a specific issue/problem (i.e., strange odors, smoke detector/CO detector installations and/or battery change outs, etc.).
- 4. Fire Alarm Calls (5%) This type of call includes malfunctioning fire alarms, intentional/unintentional false alarms, or calls where someone called to report an issue that turned out to not be an emergency (illegal burning, smells/sight of smoke or fire, or steam confused for smoke).
- 5. Hazardous Condition (3%) These are calls for service where fire crews are responding to natural gas/CO investigations, fuel/oil spills, and/or arching or downed electrical lines.
- 6. Fires (1%)- Fire loss reported= \$15,000.


## **MUTUAL AID/JOINT RESPONSE DATA**




#### **BTFD Rceived & Povided YTFD**



#### **Mutual Rceived & Povided YTFD**








#### **Turnout Times EMS Calls For Service By Fire Stations**




Turnout Times Fire Calls For Service By Fire Stations




**Overall Average Monthly Response Time** 




## **CALLS FOR SERVICE BY DISTRICT**

## TRANSPORTS BY MEDIC UNIT/MONTH




## **Monthly Staffing Levels**
