RESOLUTION 11-R-51

A RESOLUTION AUTHORIZING THE CITY MANAGER TO EXTEND THE CONTRACT WITH RUMPKE OF OHIO, INC. FOR SOLID WASTE, CURBSIDE RECYCLING, YARD WASTE AND BULK ITEM COLLECTION

WHEREAS, the Council of the City of Vandalia has determined that it is in the best interest of the City to extend the agreement with Rumpke of Ohio, Inc. for solid waste, curbside recycling, yard waste and bulk item collection services, subject to certain adjustments.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF VANDALIA, MONTGOMERY COUNTY, OHIO, THAT:

Section 1. The agreement dated December 30, 2005, as amended, between the City of Vandalia and Rumpke of Ohio, Inc., (the "Contract") a copy of which is on file in the office of the clerk of council, is hereby extended for four years and is amended as set forth in the addendum to agreement effective January 1, 2012, (the "Addendum") a copy of which is also on file in the office of the clerk of council.

Section 2. Robert L. Anderson, city manager, is hereby authorized to extend the Contract and execute the Addendum on behalf of the City.

ADDENDUM

This document serves to add the following to the contract dated December 30, 2005 (the "Contract") between the City of Vandalia, Ohio (the "City") and Rumpke of Ohio, Inc. (the "Contractor").

It is hereby agreed as follows:

Effective January 1, 2012 and continuing through December 31, 2015 Rumpke shall continue to provide one (1) time per week solid waste, curbside recycling, yardwaste and bulk item collection services for all single-family residences and multiple-family residences. Rumpke will continue to invoice the City for these services as follows:

Curbside:	\$7.85 Per Unit Per Month
Recycling:	\$1.83 Per Unit Per Month
Carry-Out:	\$8.61 Per Unit Per Month
Containerized:	\$7.05 Per Unit Per Month
Bulk:	\$.27 Per Unit Per Month
Yardwaste Bags:	\$1.70 Each

Rates quoted above will be subject to a fuel surcharge to be added to the monthly invoice based on the attached Fuel Surcharge Table. This fuel surcharge will be adjusted on a monthly basis based on the Department of Energy's Energy Information Administration (DOE/EIA) highway diesel price index reading for the Midwest region on the last Monday of the month.

The City's monthly invoice will also continue to reflect a monthly charge for the State of Ohio surcharge increase (at \$2.75 per ton) and the Montgomery County Generation Fee/Disposal increase (at \$2.50 per ton) based on actual monthly tonnage.

Rumpke will provide weekly collection from bus stops within the City on National Road and Dixie Highway (or other bus stops as otherwise added) at no charge to the City.

All other terms and conditions of the original contract dated December 30, 2005 (and subsequent Addendums) shall remain unchanged.

In the event that Rumpke incurs increased costs (such as, but not limited to, tipping fees, disposal fees, or increased surcharges, fees or taxes as a result of imposition of new governmental regulations not in effect at the time of acceptance of this Addendum and which regulate the type of material collected, the location for disposition of such material, or the payment of fees for disposing of such materials), Rumpke reserves the right to present these additional costs to the City and request the pass-thru of the increased costs to the City. In the event the City denies the request for pass-thru of these increased costs, either party may terminate this contract upon 150 days written notice to the other party.

The term of this contract extension shall be for four (4) years effective January 1, 2012 and continuing through December 31, 2015. This contract will be automatically extended for one (1) additional option year unless written notice is provided by the City of its intent not to renew at least ninety (90) days prior to the December 31, 2015 expiration date with rates to be as follows for the one year extension period:

Curbside:	\$7.97 Per Unit Per Month
Recycling:	\$1.86 Per Unit Per Month
Carry-Out:	\$8.74 Per Unit Per Month
Containerized:	\$7.15 Per Unit Per Month
Bulk:	\$.27 Per Unit Per Month
Yardwaste Bags:	\$1.70 Each

The above quoted rates will continue to be subject to the monthly fuel surcharge.
