Both Sibcy Cline and Sister Cities honored me with the opportunity give updates on our pursuit of <u>City Council's 2022 Policy Goals</u>, our success at stretching taxpayer dollars through aggressive pursuit of grant funding, and other exciting developments. It is not too early to press your lederhosen and you're your calendars for Oktoberfest on September 9 & 10! Attendees at both meetings asked many questions and

Moody's has assigned the City of Vandalia a Aa2 bond rating. The assessment was necessary in preparation for bond issuance for the City's infrastructure project. Director Leiter and Assistant Director Carnes put forth great effort to fulfill the requirements of this process. This is great news as most cities our size have a lower rating of Aa3. This is a strong testament to the City's tradition of fiscal sustainability. I have enclosed the press release and will share the in-depth bond prospectus with you.

This week, the Police Division received a thank you card from residents who were thankful that our Police Officers perform vacation checks as a value-added service. This can be requested through the My Vandalia App.

On Monday, Mayor Herbst will share a proclamation declaring May 2022 Bicycle Month in the City of Vandalia. In the coming years, I look forward to helping our team achieve some of the 2020 Vision Vandalia Comprehensive Plan goals by improving bikeability and active transportation options.

- 1. Verify items on the agenda.
- 2. **Resolution 22-R-38: Creation of Infrastructure Fund T**he City has updated building fees to include a \$1 per square foot infrastructure fee for commercial development. This fund will be created to track revenues and expenditures relating to improving and maintaining public infrastructure.
- 3. **Emergency Ordinance 22-14: Assessments** This emergency ordinance assesses properties for delinquent accounts related to storm water fees, trash collection, and delinquent sewer & water.

Monday, May 2, 2022 Items

- 1. Variance: Front Yard Setback/527 Goldleaf Avenue The Applicant, Jerry and Barb Sutter, has requested a variance to allow for the construction of an 8' x 20' front covered porch to encroach 8' into the required 35' front setback. The front porch extends across approximately 43% of the width of the front façade thus would be required to meet the principle front setback. The Board of Zoning Appeals voted 4-0 to recommend approval of the requested variance.
- 2. Ordinance: Rezoning Gateway Business to Highway Business/3324 Benchwood Road The Applicant, RVP Engineering, LLC, on behalf of EROP has submitted an application requesting a rezoning of the property located at 3324 Benchwood Road from Gateway Business (GB) to Highway Business (HB). The purpose of this request is to allow for the construction of an automatic express carwash. The Planning Commission voted 3-0 to recommend denial of the proposed amendment



to the City's Zoning Map.

3. Conditional Use - Car Wash/3324 Benchwood Road - The Applicant, RVP Engineering, LLC, on behalf of EROP has submitted an application requesting a conditional use permit for the use of "carwash" on the property located at 3324 Benchwood Road. This request is running concurrently with the rezoning request for this property. The Planning Commission voted 2-1 to recommend denial of the conditional use.

Discussion Items

- 1. Dog Leg Road Utility Expansion There is no public water or wastewater system west of the Airport Access Rd. within the municipal corporate limits. On Monday, I will ask for permission to put this project out for bid and begin the process of funding the project through issuance of Bond Anticipation Notes or a Bond. I anticipate that debt service will be paid back over 10 20 years through forthcoming tax increment financing proposals, infrastructure fees, and utility revenue. Utility extension is necessary given growing development interest and the City's desire to provide these services within its corporate limits (instead of allowing Dayton, Union, or Montgomery County to service the areas). The City has obtained an engineer's estimate of approximately \$5 million to complete Phase I of the project, which includes extending the water and wastewater system from the east side of the Airport Access Rd. to Dog Leg Rd. I have enclosed a map and a summary of the engineer's estimate. Due to ubiquitously slow procurement, I am doubtful that Phase I will be completed by the end of 2023. In response to interest from property owners and potential developers, I anticipate returning to Council to discuss engineering and proceeding with Phase II of the project before the end of the year so that utilities may be extended west of Dog Leg Rd. to the municipal limits.
- 2. March Financial Report Mrs. Carnes will deliver the March 2022 Financial Report
- 3. Staff Restructuring Department of Public Service and City Manager's Office: Over the last year, we have worked as a team to set our Policy Goals and legislative agenda for improving quality of life in Vandalia. With our staff, I have analyzed the functionality and pinch points within our organization. There are many projects in the pipeline, which cannot be achieved while maintaining continuity of services under the current staffing model. From this analysis, I have determined that it is necessary for the City to recruit and to hire a City Engineer. In addition, it is necessary to bring on a Zoning and Planning Coordinator. I will walk you through my reasoning for this proposal. In previous years, positions in the City were left unfilled an appropriate and wise decision. As we gear up for more paving, commercial and residential development, and revitalization; we need to mobilize resources. As public administrator, I also recognize the need to consider demobilizing resources through attrition at every opportunity which is why I wrote it into a policy that I recently shared with Council and staff. Thank you for your consideration of this matter. I look forward to deliberating this analysis with you. With your approval, I will return to Council to update the General Services Pay Plan and ask that you fund the positions later this year.

Resolutions

- 1. Resolution 22-R-36: Air Show Chalet Agreement Annually, the City enters into a Letter of Understanding with the US Air and Trade Show. Per the terms of the Letter, the City agrees to provide Police and City services in direct support of the 2022 CenterPoint Energy Dayton Air Show being held this year on July 30 & July 31. The City will be reimbursed should such services exceed \$21,900.
- 2. Resolution 22-R-37: Pace Labs Agreement: This resolution authorizes a two-year agreement with Pace Analytical Services for bacteria testing of our potable water system as well as wastewater sampling of required sites to meet our Municipal Industrial Pretreatment Program. In 2021 the City expended about \$25,500 with Pace. The City has utilized Pace Analytical Services of Englewood for several years for laboratory testing services, as does NAWA. We are able to drop our samples off at NAWA where they are picked up by Pace, thereby saving the City a service charge. When reviewing nearby laboratory facilities to get competitive quotes the closest labs are located in either Dublin or Lima. Utilizing one of these facilities would require additional man-hours for delivery or additional service charges for pickup. Furthermore, when testing is needed in an emergency (i.e., water main break, boil advisory) these labs would not be as convenient. Therefore, it is recommended that Council authorize this two-year agreement with Pace Analytical Services for the City's potable water and wastewater sampling and testing services.
- 3. **Resolution 22-R-38: Creation of Infrastructure Fund T**he City has updated building fees to include a \$1 per square foot infrastructure fee for commercial development. This fund will be created to track revenues and expenditures (including debt service) relating to improving and maintaining public infrastructure.

<u>Ordinances – First Reading</u>

1. Ordinance 22-15: Downtown Overlay - Vandalia City Council authorized Staff to initiate an application for a zoning map and text amendment. The proposed zoning code amendment is for the purpose of creating a new Overlay District, Vandalia City Center Overlay (VCCO), which includes its purpose, proposed location, uses, development standards, and applicability to other existing regulations. The Planning Commission voted 5-0 to recommend approval of the proposed amendments to the City's Zoning Code and Zoning Map.

Ordinances - Second Reading

1. Ordinance 22-13: PUD Preliminary Plan / 3330 Mulberry Road / 11 Acres Across from Copperfield - The Applicant, DDC Management, has submitted an application requesting a Planned Unit Development (PUD) Preliminary Plan for a single 11-acre parcel located at 3330 Mulberry Road. The Applicant is proposing to construct 87 owner-occupied attached townhome units in both two-unit buildings or three-unit configurations on the site with a density of 8 units per acre. This proposal is consistent with the 2020 Vision Vandalia Comprehensive Plan. The Planning Commission voted 4-1 to



recommend approval of the proposed Preliminary Planned Unit Development Plan with the following conditions:

- 1. Mulberry Road Right-of-Way is improved in accordance with city code section 1234.09(F) "Responsibility for Thoroughfare Improvements" east of their entrance to ensure the city has infrastructure in place for future development.
- 2. Instead of Mulberry Right-of-Way improvements made west of their entrance, a vegetative screen with a variety in evergreen trees along the Access Road Ramp to better increase sound damping for this community and surrounding areas.

Please consider the following notes relating to the proposed developments:

Resident Concern: School Enrollment

To build trust and confidence, I have spoken or corresponded via email with some residents in the area to understand the concerns, they may have. Residents near the proposed developments have raised concerns about crowding in the Vandalia Butler City School District. Superintendent O'Leary and I have discussed the concern on two occasions. I have enclosed a table detailing the matriculation from 2012 to present and forecasting enrollment into 2027. You may recall that during our joint meeting between the City, VBCSD, and Butler Township; that the school district encouraged residential construction. From 2012 to present, enrollment has dropped by 18.47%. The school district forecasts that enrollment will decline from 3,313 in 2012 to 2,591 in 2027 – a 21.79% decrease. The last US Census showed that Vandalia population shrank for the first time – ever. Projections that have been provided to the City by Pros Consulting for the Parks & Recreation Master Plan show that the City's population will likely remain consistent – and that the population will be slightly older on average – resulting in fewer student-age residents.

Resident Concern: Noise Abatement

The Ohio Department of Transportation has indicated that its policies exclude this proposed development from ODOT funded noise abatement. Instead, ODOT has stated that noise abatement could be achieved through private construction and funding of a noise barrier on private property (at an anecdotal estimate of \$1,000,000 per mile) or through the construction of earthen berms that would be the responsibility of the developer. This is an important long-term consideration. Please note the relatively short length along Airport Access and exit ramp from I-70 compared to the subsequent development that could take place along I-70 over decades. In this case, it is worth debating whether Council's directives may influence subsequent developments and pressure for Council to fund noise abatement measure after-the-fact in the future.

Ordinance - Emergency Reading

1. **Emergency Ordinance 22-14: Assessments** - This emergency ordinance assesses properties for delinquent accounts related to storm water fees, trash collection, and delinquent sewer & water.

Variance



1. Variance: Expansion of a Non-Conforming Use - 7615 Poe Ave / Rush Trucking - The Applicant, Rush Truck Centers of Ohio, Inc., has requested an expansion of a nonconforming use. The subject property is zoned Highway Business (HB). Per City Code Table 1218-1: Principally Permitted Uses in Base Zoning Districts, the use of "Truck and Heavy Equipment Sales" is listed as conditionally permitted within the Office/Industrial Park (O/IP) and Industrial (I) Zoning Districts only. The Board of Zoning Appeals voted 4-o to recommend approval of the requested expansion of a non-conforming use.

The April 18 Study Session and City Council Meeting will be a hybrid (in-person & remote) meeting in Council Chambers. The meeting is open to Council, staff, and the public to attend in-person or virtually through Zoom (LINK). The study session will begin at 6:00 pm followed by the City Council Meeting at 7:00 pm.



Rating Action: Moody's assigns Aa2 to the City of Vandalia, OH's GOLT bonds

New York, April 08, 2022 -- Moody's Investors Service has assigned a Aa2 rating to the City of Vandalia, OH's \$10 million General Obligation (Limited Tax) Capital Facilities Bonds, Series 2022. Moody's maintains the city's Aa2 issuer rating as well as the Aa2 rating assigned to the city's previously issued general obligation limited tax (GOLT) bonds. Following the sale of the current offering the city will have a total of \$10.8 million in outstanding long term GOLT debt.

The issuer rating represents Moody's assessment of hypothetical debt of the city supported by a general obligation unlimited tax (GOULT) pledge. The city does not currently have any outstanding debt supported by a GOULT pledge.

RATINGS RATIONALE

The Aa2 issuer rating reflects the city's strong financial position based on its recent string of consecutive operating surpluses and maintenance of robust fund balance and liquidity. Its strong balance sheet provides ample cushion against potential fluctuations in its main operating revenue stream, income taxes. Additionally factored are the city's moderately-sized tax base with below average wealth, diverse employment base, and average resident income indices. The rating also incorporates the city's moderate debt burden and elevated pension burden.

The lack of distinction between the issuer and GOLT ratings reflects the city's full faith and credit pledge to pay debt service on the GOLT bonds. The pledge supporting the city's GOLT bonds is considered limited tax based on the state's statutorily imposed limit of ten-mills on the ad valorem property taxes pledged.

RATING OUTLOOK

Outlooks typically are not assigned to local governments with this amount of debt.

FACTORS THAT COULD LEAD TO AN UPGRADE OF THE RATING

- Material economic and tax base expansion or strengthening of wealth and resident income metrics
- Moderation to the city's debt and pension burden relative to full value and annual operating revenue

FACTORS THAT COULD LEAD TO A DOWNGRADE OF THE RATING

- Pronounced economic or tax base contraction
- Sustained material narrowing of operating fund balance or liquidity
- Significant increases to the city's debt or pension burdens

LEGAL SECURITY

The city's outstanding and upcoming bonds are unvoted general obligations that carry the city's full faith and credit pledge. The bonds are payable from all legally available city resources including the collection of ad valorem property taxes within the ten-mill limitation imposed by Ohio (Aa1 stable) law.

USE OF PROCEEDS

Proceeds from the Series 2022 bonds will be used to finance energy conservation projects, including roof replacement and HVAC improvements, to city facilities.

PROFILE

The City of Vandalia encompasses 12.4 square miles of Montgomery County (Aa1) in southwest Ohio (Aa1

stable), approximately 10 miles north of the City of Dayton (Aa2 stable). The city operates under a councilmanager form of government and provides comprehensive municipal services, including certain utilities, to a community of approximately 15,000 residents.

You Never Know




