Honorable Mayor Herbst & Esteemed City Councilmembers:



Thank you for your hard work and deliberation during our recent Council meeting and spring retreat. It was great to touch base and provide you with updates regarding the broad performance goals that we are pursuing in 2023. This is truly a great time to be in service to the City of Vandalia. We are on an upswing, and it is important that we leverage our strategic planning, capital improvement plan, advanced budget forecasting, and expertise to follow through with great policy decisions.

Veteran Banners: Public Works crews along with Butler Township crews have been installing the Veterans Banners along Dixie Drive from National Road to Stop Eight Road. There has been a lot of cooperation for this and we are proud to be a part of this great project and thank everyone involved who made this possible.

The Sweet Treats Festival, held on Saturday, May 13 at the Art Park was a big success. Congrats to the Vandalia team on a wonderful event. My children left with bellyaches and had tons of fun running through the amphitheater. The jazz music was a hit. Approximately 2,000 people attended. The weather let up

and it was a perfect day for live music, vendors and food trucks. Recreation Coordinator Aaron Messenger did an outstanding job planning and coordinating. This event was featured on Dayton.com (link to photo gallery). This effort to create events to bring the community together is a direct result of the City's 2020 Vision Vandalia Comprehensive Plan and the 2023 Parks & Recreation Master Plan.

VRC Front Desk Training: Administrative Coordinator Sharon Hamby and Facility Manager Alicia McCracken conducted a Front Desk Staff Meeting and Training on May 10. They covered topics such as customer service, communications, procedures, and processes. They discussed empowerment and the ability and resources to turn negative situations into positive outcomes.

Ernst Concrete: The contractor has begun the site work for the Ernst Enterprise corporate office at 993 Falls Creek Drive.

Cassel Hills Golf Course: Play at the golf course in the month of May is down by 150 players compared to the same period last year due to weather. Although greens and cart fees are up by \$500 due to the recent rate increase.

Tree City USA Recognition: Parks Maintenance Technician Bryan Fine is pictured accepting the City's 9th year designation plaque in recognition of our Tree City USA achievement.

Revitalization Efforts: Recently, I have met with several business owners and potential partners to share the City's efforts to promote

strategic development to make Vandalia a more walkable place where people can gather and linger.



Based on community feedback, we are working to create opportunities that would result in more sitdown restaurants, office space and attractive housing options. Thank you for the opportunity to share these details at the retreat earlier this week.

Facilities Infrastructure Project Updates: The HVAC and roof work at the Recreation Center continues as we are coming to the end of week 6 of the shutdown of the aquatic center. Work is scheduled to be completed in 6-8 weeks. Municipal Building duct work cleaning has been completed and HVAC controls work is being finalized. Justice Center HVAC roof top units are due to be replaced as soon as the equipment arrives, currently scheduled for mid-June. VRC daily admissions for April are down by \$10,000 over last year mainly due to the closure of the aquatic center for the HVAC and roof project.

Public Works Kids Day: The Public Works team hosted third graders from Helke Elementary, Demmitt Elementary and St. Christopher schools this week to give first-hand knowledge and to teach them about the services we provide. It was good to reestablish this tradition.

Focus Vandalia – Forthcoming: Our next Focus Vandalia filming will be Wednesday, May 24. We will cover the following topics: include Vandalia's Bee City USA designation, Introducing Ben Borton as City Engineer, the 2023 Street Resurfacing Program, Preview of the Star-Spangled Celebration.



Finance Training: Finance Administrative Assistant Micki Weber and Finance Clerk Tiffany Barnes attended an Introduction to the Finance Office and Governmental Accounting seminar recently. Across the organization, our team is working to provide staff with the training opportunities they need to build our bench of leaders and to give our team the professional development they need to make Vandalia a top-tier suburb through top-tier city services.

Hydrant Flushing: Crews have been out finishing up hydrant flushing. This annual task will be completed before the end of the month and as seen on our social media, crews have had a chance to interact and make friends with the community while out checking hydrants.

Water Meter Installations: The Public Works team continues to install new water meters



(approximately 110 so far). The Finance department is contacting residents with failed meters and scheduling replacements. We have also started replacing the dead meters that are in the pits outside the homes. We are leaving door hangers (enclosed) to let residents know that their meter was replaced if they are not home.

Commercial Truck Traffic: During the past two weeks, VPD officers made 25 traffic stops on commercial motor vehicles for traffic violations. These stops resulted in six traffic citations, 18 written warnings and one verbal warning while working 16 additional enforcement hours.

Director Cron is reviewing preliminary traffic count results. He has ordered an additional simultaneous video count at US-40 / Airport Access Rd. and US-40 / Dixie. Director Cron and I, possibly with the assistance of Mr. Jason Oaks, plan to give an update on the results of these measurements at the June 19, 2023 meeting of City Council.



Cassel Hills Pool will open for the summer on Saturday, May 27 and staff is working to get everything in place, including conducting training and expectation sessions with SwimSafe staff. The management team for the summer will include Mr. Aaron Baker (a teacher by trade) as Manager and three assistant managers who worked with us last year.

Missing Child Found Sleeping in Neighboring Car: On May 11, VPD Officers and VFD responded to a missing 7-year-old male on Great Hill Drive. The mother had just arrived home from soccer practice, and one child didn't go inside the home. A significant search was conducted by the police department and the Vandalia Fire Department. Butler Township Police Officers and other area detectives assisted with the search, along with the Huber Heights Fire Department drone. The Vandalia Fire Department utilized two of their drones to search the neighborhood, wooded area, and pond. Police officers and firefighters went to every home in the neighborhood attempting to find the missing juvenile. In addition, numerous citizens in the neighborhood volunteered and searched for the missing juvenile. After the large search tactics were exhausted, a plan for a detailed grid search was formulated and utilized. Within minutes, the missing juvenile was located. He had entered a neighbor's unlocked car, covered himself with a blanket, and fallen back asleep. The juvenile was reunited with his mother. Capt. Miller, Lt. Carter, and Sgt. Nagel are completing an after-action report for this event. Chief Follick noted and complimented the coordination and leadership of Cpt. Miller and Sgt. Nagel during the incident.

Run, Hide, Fight Training: CPO Wehner met with Mr. Scott Fullman at Keller Williams on Wednesday, May 17 during their scheduled sales meeting. Officer Wehner provided Run, Hide, Fight training for the approximately 40 attendees. The training was well received and most in attendance were unaware of the available text to 911 feature. We look forward to providing information like this to our businesses and citizens throughout the community.

Foley / Enola Drive Reconstruction: I have enclosed a sample letter that was delivered to residents regarding the project. The next step in the project will be concrete work including the installation of curbs and sidewalks. This will take several days, weather permitting. Residents are advised that they must have their vehicles out of their driveways by the morning of Monday, May 22 (this may be moved to May 23rd). Residents will be unable to access their driveways for approximately five days after the concrete is poured. This is a normal interruption for a full depth reconstruction project. As a general update, Double Jay Construction has completed the underground utility work on the Foley/Enola Drive project. They are currently excavating and installing gravel bases for the roadway.

Utility Extension Project Phase I: Outdoor Enterprise continues to make progress on the Dog Leg Road Utility project. The roadway is back open. They intend to install most of the remaining utilities (e.g., water main, sanitary sewer force main) by directional drilling the lines. This will significantly reduce the amount of traffic interruption and roadway repairs that would have been required if the trenches were excavated. This also eliminates sign relocation, tree replacement, and parking lot restoration for the church at 8986 Dog Leg Rd.

Concrete Project: Finfrock Construction has started this year's curb & sidewalk replacement program. They began excavating last week and have started to pour back the new section of curb and sidewalk this week. They are currently working in the neighborhood behind the Municipal Building on Inverness Avenue and North American Blvd.

 submitted to the County for collection; information regarding the upcoming debt
 payments and issuance of new annual Land Acquisition and Bond Anticipation Notes
 for the development in Stonequarry Crossings, fire engine and fire ladder truck. I also
 presented financial reports for April 2023 YTD.
- 2. Finance continues to provide data to the compilation team and auditors from Plattenburg and Associates for the 2022 Annual Report and audit.

On May 8th crews responded to North Brown School Rd. on a reported structure fire.

<u>RECREATION / ATHLETICS DIVISION / SPECIAL EVENTS</u>

The Sweet Treats Festival, held on Saturday, May 13 at the Art Park was a big success. An estimated turnout of 2,000 people attended the first time event that included live music, vendors and food trucks with an emphasis on sweet treats. Recreation Coordinator Aaron Messenger did an outstanding job planning and coordinating this first time special event. Events that bring the community together is one of the Master Plan recommendations.

Cupcakes and Canvases, a program in which families painted canvases and enjoyed cupcakes was held on May 2 at the Senior Center with 26 in attendance.

Cassel Hills Pool will open for the summer on Saturday, May 27 and staff is working to get everything in place, including conducting training and expectation sessions with SwimSafe staff. The management team for the summer will include Aaron Baker as Manager and Nathan Mercier, Hunter Sheafer and Lexi Reich as Assistant Managers. All three Assistants are returning from last year.

The Corporate Challenge Captain's Meeting was conducted on May 5 with seven teams in attendance. The event will take place June 4-9. The number of participating teams are down from past years so we will be working with current and past business teams to determine what the annual event will look like as we move into the future.

The first session of Start Smart Baseball/Softball was held on May 10 with 53 participants. This program is for 3-4 year olds and involves the basics of the sport. The Butler High School JV baseball team assisted with the program.

RECREATION CENTER

Golf Maintenance encountered an issue with a rough mower last week as the intake manifold sensor went out. The new sensor is \$1,000 and once the device arrives it will be installed and the unit will be back in operation.

Vandalia Baptist Church rented the Clubhouse for a prom-like event for their teenage members on May 5th after previous plans fell through at the last minute. Twenty-five students attended and the church was extremely appreciative golf course staff was able to accommodate them at the last minute. Kudos to Ben Lickliter and Carl Hafer for going above and beyond to make this event happen for the local church. Their efforts demonstrates a commitment to the vibrant city wide policy goal.

SENIOR CITIZENS CENTER

Van Tran continues to be a valuable resource to the seniors in our community. The program provided 167 one-way rides in the month of April bringing the yearly total to 660.

The Senior Center averaged 82 member visits per day during the period of May 2-16 with May 2 being the busiest of the time period with 154 member visits.

FACILITY MAINTENANCE DIVISION

Facility Maintenance staff is working on building, mechanical and grounds preparations at Cassel Hills Swimming Pool which is scheduled to open in a little over one week (Saturday, May 27). Service to the pool boiler was completed this week as well.

Custodial staff has completed floor care maintenance at the Justice Center in anticipation of the CALEA certification process for the Police Department.

The Arbor Day Celebration was a success with over 350 Helke Elementary students and teachers on hand for the event. An Autumn Fest Sugar Maple tree was planted and 350 bare root White Flowering Dogwood trees distributed to each student in attendance. Information about Arbor Day and tree planting tips were shared during the event. We appreciate Mayor Herbst delivering a proclamation and speaking with the students.

Facility Maintenance staff has completed the spring planting of commemorative trees. Four were planted near the Recreation Center and included Autumn Gold Ginkgo, Lustre Serviceberry and a Rugged Charm Maple trees.

The drought last summer and fall has stressed some of our trees. We have lost two Elm along National Road Streetscape. Staff is in the process of removing deadwood on some of our smaller trees in our parks. They watered about 75 trees last summer and fall to combat the dry conditions and allow the trees to survive.

Work is scheduled to be completed in 6-8 weeks. Municipal Building duct work cleaning has been completed and HVAC controls work is being finalized. Justice Center HVAC roof top units are due to be replaced as soon as the equipment arrives, currently scheduled for mid-June.

- 1. During the past two weeks, VPD officers made 25 traffic stops on commercial motor vehicles for traffic violations. These stops resulted in six traffic citations, 18 written warnings and one verbal warning while working 16 additional enforcement hours.
- 2. On May 5, Lt. Sucher and Sgt. Lawson attended Career Day at Morton Middle School. They interacted with approximately 200 students regarding interest in the field of policing as well as discussing VPD and the services provided.
- 3. During the week of May 8, VPD held the second round of police officer interviews. An eligibility list was certified as a result with 5 candidates moving to the next phase of the hiring process.
- 4. On May 9, SSM Kanzari virtually participated in a Customer Configuration meeting for the new Intrado Viper 911 system. This system replaces the 911 equipment from the December 25 water damage. Technicians will be on-site on June 21 for installation.
- 5. Detectives charged two West Milton residents (husband and wife) with Illegal Use of Minor in Nudity Oriented Material (ORC#2907.323(A)(3)/ F5) after getting a report from an independent watch organization that someone was sending nude juvenile pictures to another. One spouse was requesting the other spouse to send nude teen pictures while the one spouse was working in Vandalia. (CFS# 23-11498).
- 6. On May 12, VPD participated in the Montgomery County Drug Free Coalition Blitz. Vandalia, Butler Township, and northern Harrison Township were a focus of enforcement efforts.
- 7. Officers Coatsworth and Wehner joined students from Morton Middle School on Wednesday, May 17 for bicycle ride starting at Kyle Park in Tipp City. Groups of students were paired with the officers and other advisors as they enjoyed a ride south on the bike path to the Taylorsville Dam. This was a great opportunity to humanize the badge and get some positive interaction. We appreciate Morton for inviting us!





- 8. CPO Wehner met with Scott Fullman at Keller Williams on Wednesday, May 17 during their scheduled sales meeting. Officer Wehner provided *Run*, *Hide*, *Fight* training for the approximate 40 attendees. The training was well received and most in attendance were unaware of the available text to 911 feature. We look forward to providing information like this to our businesses and citizens throughout the community.
- 9. On May 11, VPD Officers responded to a missing 7-year-old male on Great Hill Drive. The mother had just arrived home from soccer practice, and one child didn't go inside the home. A significant search was conducted by the police department and the Vandalia Fire Department. Butler Township Police Officers and other area detectives assisted with the search, along with the Huber Heights Fire Department drone. The Vandalia Fire Department utilized two of their drones to search the neighborhood, wooded area, and pond. Police officers and firefighters went to every home in the neighborhood attempting to find the missing juvenile. In addition, numerous citizens in the neighborhood volunteered and searched for the missing juvenile. After the large search tactics were exhausted, a plan for a detailed grid search was formulated and utilized. Within minutes, the missing juvenile was located. He had entered a neighbor's unlocked car, covered himself with a blanket, and fallen back asleep. The juvenile was reunited with his mother. Capt. Miller, Lt. Carter, and Sgt. Nagel are completing an after-action report for this event.
- 10. On May 13, VPD crews responded to an apartment fire on Imperial Court. Officer Matlock was one of the first to arrive and entered the apartment which was quickly filling with smoke. There was an active fire surrounding an occupant. Officer Matlock pulled the unresponsive resident from the apartment with the assistance of Officer Clymer. Matlock dragged the resident to a safe location and then both he and Officer Clymer re-entered the building to alert occupants to vacate. This was a great effort by our officers and responding VFD crews.
- 11. On May 17, Lt. Sucher virtually attended the R.A.N.G.E Task Force Executive Board meeting.

Development & Engineering Services

Double Jay Construction has completed the underground utility work on the Foley/Enola Drive project. They are currently excavating and installing gravel base for the roadway. They tentatively have the curb scheduled to be poured next week. We have delivered letters (see below) to all residents along this section of roadway advising them of the upcoming work.

Outdoor Enterprise continues to make progress on the Dog Leg Road Utility project. The roadway is back open. They intend to install the majority of the remaining utilities (watermain/sanitary sewer force main) by directional drilling the lines. This will significantly reduce the amount of traffic interruption and roadway repairs that would have been required if the trenches were excavated. This also eliminates sign relocation, tree replacement, and parking lot restoration for the church at 8986 Dog Leg Rd.

Finfrock Construction has started on this year's curb & sidewalk replacement program. They began excavating last week and have started to pour back the new section of curb and sidewalk this week. They are currently working in the neighborhood behind the Municipal Building on Inverness Avenue and North American Blvd.

We opened bids for our annual Street Resurfacing project on May 9th and the bid was awarded to Barret Paving Materials at last Monday's City Council meeting.

We have also placed the order for the four Rapid Flashing Beacons that were authorized at the meeting on Monday.

Ben Borton attended the Pre-Construction meeting held by Montgomery County Engineer's office for the Dixie Drive Asphalt Repairs for which we will be partnering with the County.

They have begun the site work for the Ernst Enterprise corporate office at 993 Falls Creek Drive.

Foley & Enola Drive Residents:

I would like to thank you for your cooperation and patience during the reconstruction of your street. The contractor has made good progress to date with the utility work and excavating the roadway to prepare for the new street base and surface.

The next step in the project will be the concrete work. They will be preparing for the installation of the curbs and sidewalk in the next several days and, weather permitting, they will begin pouring the new curb next week. You will need to have your vehicles out of your driveway by the morning of Monday May 22nd. The contractor plans to do the necessary setup for the curb machine on Monday and likely begin curb installation on Tuesday. The curb installation could be a multi-day process. After the curb is in place, the contractor will begin preparing and pouring the drive approaches. During this time, you will be unable to use your driveway until approximately 5 days after the concrete for your approach is poured. You will be able to park your vehicles in front of your homes or close by at the end of each work day. But they will need to be moved first thing in the morning. During the day you will need to park your vehicles on one of the side streets (outside of the construction zone where it is currently gravel) or in the parking lot for Robinette Park.

Once the concrete work is completed, the contractor will be installing a new gravel base for the street followed by the asphalt and yard restoration.

As with all construction projects, weather can play a role in the schedule. Rain could delay the concrete work. So, the date listed above and subsequent schedule are tentative based on the weather.

The good news is that all of this work is being completed at no cost to you. We thank you again for your cooperation and patience throughout this project.

Public Works

Public Works crews along with Butler Township crews have been installing the Veterans Banners along Dixie Drive from National Road to Stop Eight Road. There has been a lot of cooperation for this and we are proud to be a part of this great project and thank everyone involved who made this possible.



This week was also "Kids Day" at the Public Works facility. As we have done now for many years, we hosted third graders from Helke Elementary, Demmitt Elementary and St. Christopher schools at our facility to give them first-hand knowledge and teach them a little bit about what we do to keep the City running. As always, the kids and our team of public servants had a great time interacting









We continue with installing our new water meters. The Finance department is contacting residents with failed meters and scheduling for the replacements. We have also started replacing the dead meters that are in the pits outside the homes. We are leaving door hangers (see attached) to let residents know that their meter was replaced if they are not home. To date we have installed approximately 110 new meters.

Our crews have formed and poured concrete for 17 monument foundations at Poplar Hill Cemetery so that headstones can be set for Memorial Day. We also have three burials to perform this week including one this coming Saturday.

We have completed the asphalt restoration from the Scott Avenue Sanitary Sewer project that was completed earlier this spring.



Crews have removed the flashing "25 MPH" signs on National Road near Dixie Drive and Ranchview Drive. We have poured the foundations in preparation for installing the radar signs at these locations similar to the one on Dixie Drive near Lakin Court. These signs alert drivers of their actual speed in an effort to get them to slow down and comply with the 25 MPH speed limit in this area.

It continues to be a busy time of year for performing utility locates for all types of excavation work throughout the City. We have performed 150 locates during this period.

We held our monthly large item drop off at the Public Works Facility on Saturday May 13th.

We have made repairs to several fire hydrants that were found to be broken by the fire department during their annual flushing of the hydrants.

Jake Hayslett, Ben Borton, and I attended the Tri Cities Wastewater Authorities technical committee meeting on May 10th.

Jake Hayslett and Walter Ritchie have both become certified for Industrial Vegetation control through the Ohio Department of Agriculture.

PUBLIC SERVICE DEPARTMENT

The Department of Public Service is staffed by dedicated and highly trained public servants who provide residents with efficient, honest, and courteous service through the divisions of Public Works and Development and Engineering Services. The department is led by our tenured Director of Public Service, Rob Cron.



PUBLIC WORKS DIVISION

The Public Works Division is responsible for general maintenance of 210 lane miles of roadways; leaf collection; fleet management and the City garage; maintenance, repair and replacement of water mains, sanitary and storm sewers; operation of Poplar Hill Cemetery; ice and snow removal; street sweeping; roadway painting; and sign and signal maintenance. The Public Works team is highly visible to our residents, businesses, and visitors. The City prides itself on ensuring a high level of customer service at every touchpoint with the public.

Full-time employees within the Public Works Division are represented by the Teamsters Local Union No. 957. The Employer and the Union entered into an initial <u>collective bargaining agreement</u> on April 20, 2020.
